PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA FEBRUARY 2019

Producer Price Index for Industrial Products increased by 0.05 percent over January 2019, while compared to the corresponding month of the preceding year the index growth amounted to 3.3 percent.

The prices for **products from mining and quarrying** increased by 1.7 percent **compared to the pre-vious month,** resulting in a 0.11 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price increase was registered for metal ores and other mining and quarrying products (1.9 percent).

Manufactured products: the price decrease amounted to 0.1 percent, which contributed -0.06 percentage points to the overall index change.

The **annual PPI** rate was mainly affected by price changes for the following products:

- Manufactured products: the prices increased by 4.0 percent, contributing 3.18 percentage points to the overall annual index growth. There was an increase in the prices for food products, beverages and tobacco products (4.5 percent), also for basic metals and fabricated metal products (5.1 percent);
- Electrical energy, gas, steam and hot water: the prices increased by 1.1 percent and contributed 0.14 percentage points to the overall PPI change.

The following table presents the Producer Price Index (compared to the previous month and the corresponding month of the previous year) and the relevant contributions of the products to the changes in the overall index.






