Producer Price Index for Industrial Products in Georgia

January 2017

In January 2017 the Producer Price Index (PPI) for Industrial Products increased 2.3 percent over December 2016. The index rose 9.8 percent compared to January 2016.

In January **compared to previous month** prices were 1.1 percent higher for **manufactured products**, resulting in a 0.90 percentage point contribution to the overall monthly PPI growth. Prices were up for basic metals and fabricated metal products (2.9 percent). Prices also increased for food products, beverages and tobacco (0.5 percent).

Prices for **products from mining and quarrying** increased 3.1 percent, contributing 0.14 percentage points to the overall monthly index growth.

Prices were also higher for **electrical energy, gas, steam and hot water** (9.5 percent), which contributed 1.24 percentage points to the overall monthly PPI growth.

The **annual PPI** rate was mainly affected by price changes for the following products:

- **Manufacturing products:** prices increased 8.8 percent, contributing 7.03 percentage points to the overall annual index growth. Prices were up for basic metals and fabricated metal products (48.3 percent);
- **Electrical energy, gas, steam and hot water:** prices increased 10.9 percent and contributed 1.90 percentage points to the overall PPI change;
- **Products from mining and quarrying:** prices surged 25.7 percent. Correspondingly, the contribution to the overall annual PPI growth amounted to 0.88 percentage points.

The following table presents the Producer Price Index over December 2016 and January 2016, with the relevant contributions of the products to the changes in the overall index.

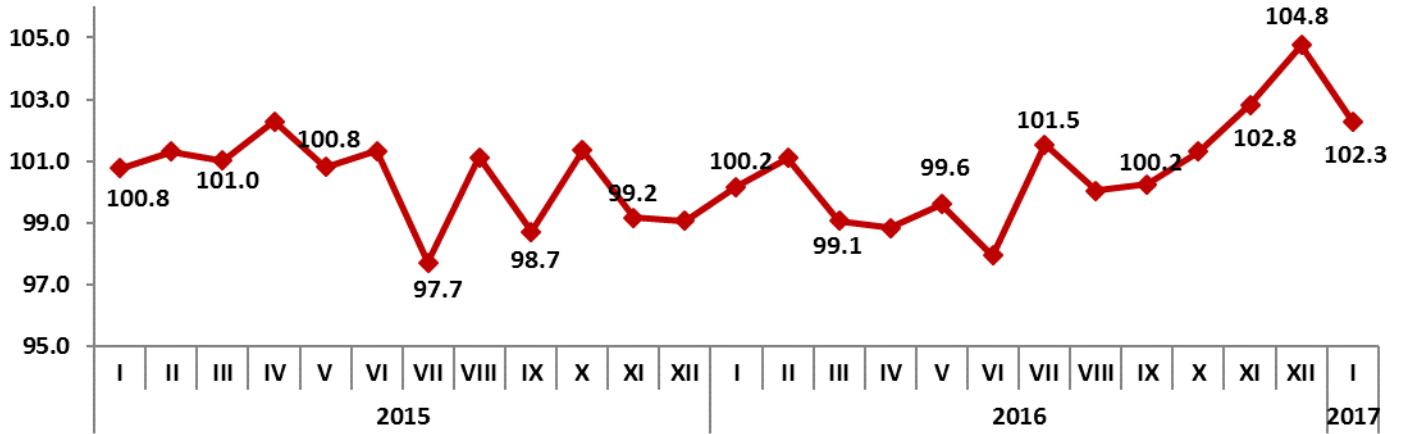

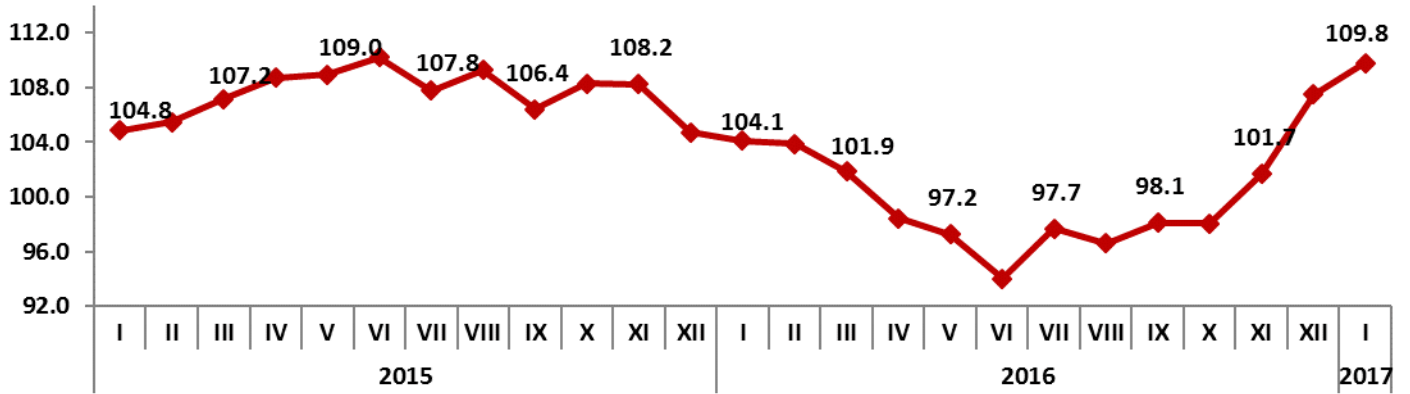

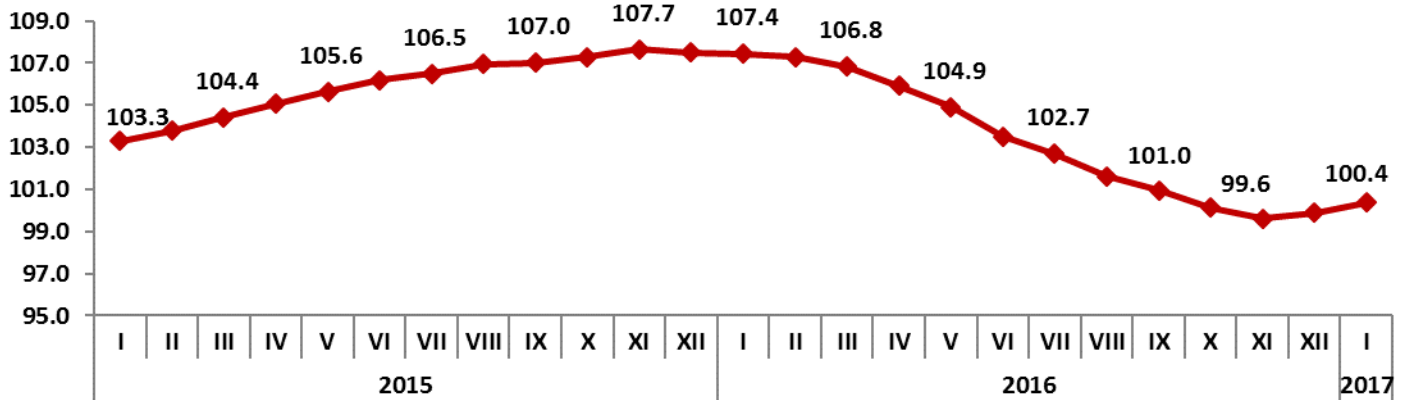
Producer Price Index for Industrial Products
