


External Trade of Georgia in January-March 2017

(Preliminary)


In January-March 2017 external merchandise trade (excluding non-declared trade) in Georgia amounted to USD 2285 million, 18 percent higher year-on-year. The exports equaled USD 577 million (30 percent higher), while the imports stood at USD 1708 million (15 percent higher). The negative trade balance was USD 1132 million in January-March 2017 and its share in external trade turnover constituted 50 percent. Export excluding re-export amounted to USD 468 million, 32 percent higher year-on-year.

Percentage changes in January-March 2017 compared to the same period of the previous years (%)



Exports and imports of Georgia



In January-March 2017 the external trade turnover of Georgia with the EU countries amounted to USD 641 million, grew by 26 percent compared to the corresponding indicator of the previous year. Exports amounted to USD 159 million (44 percent higher), while imports amounted to USD 481 million (21 percent higher). The share of these countries in the external trade turnover of Georgia amounted to 28 percent, 28 percent in exports and 28 percent in imports (in January-March 2016 26, 25 and 27 percent correspondingly). 28 percent of the trade deficit came to the EU countries (28 percent in January-March 2016).

In January-March 2017 the external trade turnover of Georgia with the CIS countries totaled USD 751 million (higher by 35 percent compared to January-March 2016). Exports stood at USD 205 million (59 percent higher), while imports equaled USD 546 million (27 percent higher). The share of the CIS countries in the external trade turnover of Georgia constituted 33 percent, 36 percent in exports and 32 percent in imports (In January-March 2016 29, 28 and 29 percent, respectively). In January-March 2017 compared to the corresponding period of the previous year, CIS countries accounted for 30 percent of the overall trade deficit (29 percent in January-March 2016).


The diagrams below show the share of the exports and imports of Georgia by country groups.



In January-March 2017 share of the top ten trading partners in the total external trade turnover of Georgia amounted to 66 percent. The top trading partners were Turkey (USD 331 million), Russia (USD 255 million) and Azerbaijan (USD 207 million).



Top trading partners by turnover in January-March 2017*



Share of the top trading partners in total exports in January-March 2017* (%)



Share of the top trading partners in total imports in January-March 2017* (%)




Major commodity groups by exports and imports

In January-March 2017 Copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 98 million, or 17 percent of total exports. Exports Ferro-alloys of totaled USD 81 million and its share in the total exports amounted to 14 percent. Motor cars occupied the third place. Exports of this commodity group stood at USD 35 million and 6 percent of the total exports.

Share of major commodity groups by exports in January-March 2017* (%)




The top import commodity In January-March 2017 were Petroleum gases and other gaseous, imports of which amounted to USD 138 million and 8 percent of the total imports. Petroleum and petroleum oils commodity group followed in the list with USD 122 million, or 7 percent of imports. Motor cars came third with USD 105 million (6 percent of imports).

The preliminary data will be revised according to the Geostat's revision policy (based on the regular revision principle) as a result of adjusting data by respondents/administrative sources.

Adjusted data for 2016 will be published on 15 July, 2017.

Information Note

The electronic Database of Customs Declarations (DBCD) is the main administrative information source of external merchandise trade transactions. National Statistics office of Georgia (Geostat) receives DBCD from the Revenue Service of Ministry of Finance of Georgia on a monthly basis. Geostat produces External Merchandise Trade Statistics in line with the international methodology /standards.

It is well-known fact that Georgia launches hepatitis C elimination program since 2015. Program recipients are granted by the medicaments free of charge. Customs value of those medicaments are based on expertise valuation.

IMF technical assistance (TA) mission on external sector statistics (ESS) was conducted in Georgia at the end of 2016. The purpose of the mission was to Geostat and the National Bank of Georgia (NBG) in strengthening the and dissemination of ESS.

One of the priority actions recommended by the mission was to adjust data on value of imported hepatitis C medicines based on information received from counterparts. This will ensure consistency between External Merchandise Trade Statistics and Balance of Payments data.

According to the provided recommendations and agreement with the National Bank of Georgia Geostat adjusted value of import of C hepatitis medicaments on the basis of invoice price received from the Revenue Service. Adjustments covered 2015-2016 years period since starting hepatitis C elimination program. Recalculation of the total import, merchandise trade turnover and trade balance was made accordingly.

Adjustment of data will ensure comparability of statistical data at the international level. Adjustments were implemented according to the Statistical Data Revision Policy of Geostat.
