

External Trade of Georgia in January- May 2017 (Preliminary)


In January-May 2017 external merchandise trade (excluding non-declared trade) in Georgia amounted to USD 3944.8 million, 14.9 percent higher year-on-year. The exports equaled USD 1003.4 million (28.7 percent higher), while the imports stood at USD 2941.4 million (10.8 percent higher). The negative trade balance was USD 1938.1 million in January-May 2017 and its share in external trade turnover constituted 49.1 percent. Export excluding re-export amounted to USD 799.8 million, 28.1 percent higher year-on-year.

The charts below reflect basic trends of the external trade of Georgia for 2012-2017:







(Million US Dollars)




In January-May 2017 the external trade turnover of Georgia with the EU countries amounted to USD 1090.5 million, grew by 15.3 percent compared to the corresponding indicator of the previous year. Exports amounted to USD 260.0 million (40.7 percent higher), while imports amounted to USD 830.4 million (9.1 percent higher). The share of these countries in the external trade turnover of Georgia amounted to 27.6 percent, 25.9 percent in exports and 28.2 percent in imports (in January-May 2016 27.5, 23.7 and 28.7 percent correspondingly). 29.4 percent of the trade deficit came to the EU countries (30.8 percent in January-May 2016).

In January-May 2017 the external trade turnover of Georgia with the CIS countries totaled USD 1285.1 million (higher by 36.0 percent compared to January-May 2016). Exports stood at USD 383.4 million (62.7 percent higher), while imports equaled USD 901.8 million (27.2 percent higher). The share of the CIS countries in the external trade turnover of Georgia constituted 32.6 percent, 38.2 percent in exports and 30.7 percent in imports (In January-May 2016 27.5, 30.2 and 26.7 percent, respectively). In January-May 2017 compared to the corresponding period of the previous year, CIS countries accounted for 26.8 percent of the overall trade deficit (25.3 percent in January-May 2016).


In January-May 2017 share of the top ten trading partners in the total external trade turnover of Georgia amounted to 65.8 percent. The top trading partners were Turkey (USD 591.1 million), Russia (USD 430.5 million) and Azerbaijan (USD 316.3 million).

(Million US Dollars)







Share of the top trading partners in total exports in January-May 2016-2017* (%)







Major commodity groups by exports and imports


In January-May 2017 Copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 170.1 million, or 17.0 percent of total exports. Exports Ferro-alloys of totaled USD 123.6 million and its share in the total exports amounted to 12.3 percent. Motor cars occupied the third place. Exports of this commodity group stood at USD 67.7 million and 6.8 percent of the total exports.


The top import commodity In January-May 2017 were, Petroleum and petroleum oils imports of which amounted to USD 238.3 million and 8.1 percent of the total imports. Motor cars commodity group followed in the list with USD 185.2 million, or 6.3 percent of imports. Petroleum gases and other gaseous came third with USD 169.7 million (5.8 percent of imports).

4. According to the international methodology, there are some difference in coverage of trade flows between external merchandise trade statistics and customs statistics. Diplomatic, temporary, transit and analogous goods are excluded from the database of external merchandise trade statistics.

The preliminary data will be revised according to the Geostat's revision policy (based on the regular revision principle) as a result of adjusting data by respondents/administrative sources.

Adjusted data for 2016 will be published on 15 July, 2017.
