Producer Price Index for Industrial Products in Georgia

May 2017

In May 2017 the Producer Price Index (PPI) for Industrial Products increased 9.4 percent over May 2016, while it remained unchanged compared to April 2017.

In May **compared to the previous month** prices were 0.6 percent higher for **manufactured products**, resulting in a 0.51 percentage point contribution to the overall monthly PPI change. Prices were up for basic metals and fabricated metal products (1.9 percent) and electrical and optical equipment (30.9 percent).

Prices decreased for **electrical energy, gas, steam and hot water** (-3.0 percent), contributing -0.42 percentage points to the overall monthly PPI change.

The **annual PPI** rate was mainly affected by price changes for the following products:

- Manufactured products: prices increased 9.1 percent, contributing 7.54 percentage points to the overall annual index growth. Prices were up for basic metals and fabricated metal products (30.9 percent), also for food products, beverages and tobacco (8.5 percent);
- Electrical energy, gas, steam and hot water: prices increased 7.8 percent and contributed 1.09 percentage points to the overall PPI change;
- **Products from mining and quarrying:** prices surged 22.2 percent. Correspondingly, the contribution to the overall annual PPI growth amounted to 0.79 percentage points.




