# Producer Price Index for Industrial Products in Georgia

# June 2017

In June 2017 the Producer Price Index (PPI) for Industrial Products increased 0.5 percent over May 2017, while the index increased 12.3 percent compared to June 2016.

In June index growth **compared to the previous month** was attributable to price increase of 0.6 percent for **manufactured products**, which resulted in a 0.49 percentage point contribution to the overall monthly PPI change. Price increases were recorded for food products, beverages and tobacco (1.1 percent) and for basic metals and fabricated metal products (1.8 percent). Prices decreased for chemicals, chemical products and man-made fibres (-3.0 percent).

The **annual PPI** rate was mainly affected by price changes for the following products:

- Manufactured products: prices increased 12.7 percent, contributing 10.49 percentage points to the overall annual index growth. Prices were up for basic metals and fabricated metal products (39.9 percent), also for food products, beverages and tobacco (11.3 percent);
- Electrical energy, gas, steam and hot water: prices increased 8.1 percent and contributed 1.15 percentage points to the overall PPI change;
- **Products from mining and quarrying:** prices were 16.7 percent higher, with the relevant contribution of 0.63 percentage points to the overall annual PPI growth.

The following table presents the Producer Price Index over May 2017 and June 2016, with the relevant contributions of the products to the changes in the overall index.





### **Producer Price Index for Industrial Products**




### **Producer Price Index for Industrial Products**
