Producer Price Index for Industrial Products in Georgia

September 2017

In September 2017 the Producer Price Index (PPI) for Industrial Products increased 2.0 percent over August 2017 and 13.4 percent compared to September 2016.

In September prices for **manufactured products** were up 2.2 percent **compared to the previous month**, which resulted in a 1.79 percentage point contribution to the overall monthly PPI change. Prices increased mainly for basic metals and fabricated metal products (5.1 percent), also for food products, beverages and tobacco (2.4 percent).

Products from mining and quarrying posted a 2.9 percent price increase, contributing 0.14 percentage points to the overall monthly index growth.

The **annual PPI** rate was mainly affected by price changes for the following products:

- **Manufactured products:** prices increased 13.7 percent, contributing 11.25 percentage points to the overall annual index growth. Prices were up for basic metals and fabricated metal products (56.4 percent), food products, beverages and tobacco (8.0 percent), also for chemicals, chemical products and man-made fibres (4.6 percent);
- **Electrical energy, gas, steam and hot water:** prices increased 9.2 percent and contributed 1.3 percentage points to the overall PPI change;
- **Products from mining and quarrying:** prices were 22.4 percent higher, with the relevant contribution of 0.91 percentage points to the overall annual PPI growth.

The following table presents the Producer Price Index over August 2017 and September 2016, with the relevant contributions of the products to the changes in the overall index.

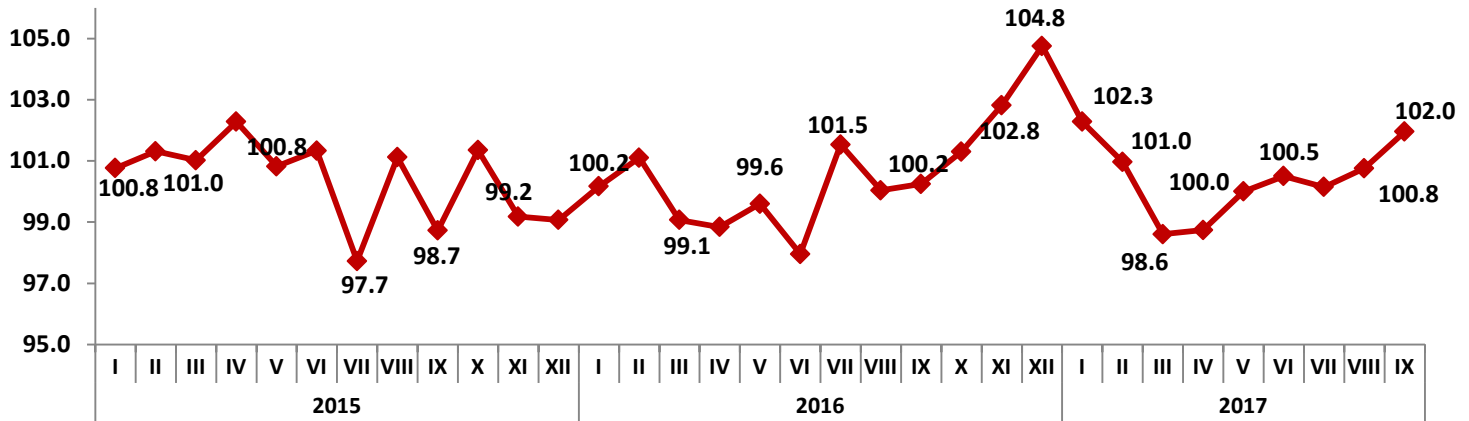

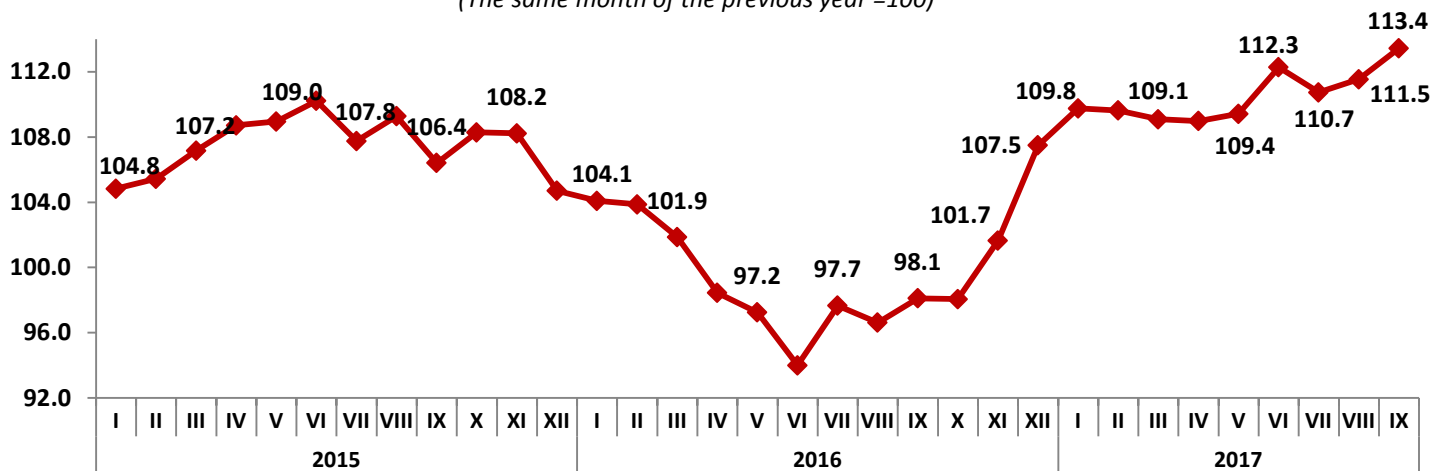

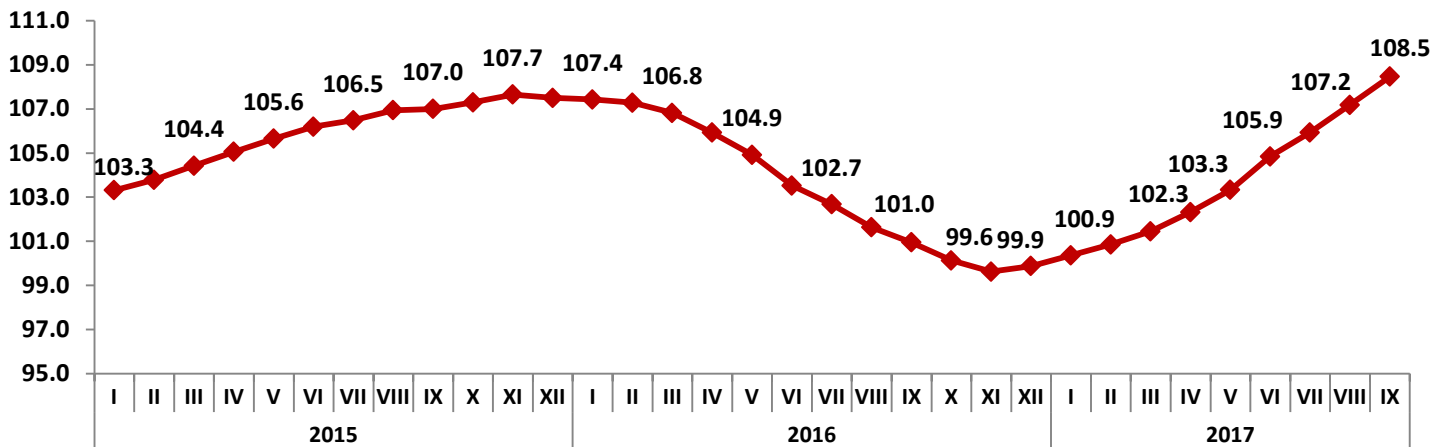
Producer Price Index for Industrial Products
