Producer Price Index for Industrial Products in Georgia

March 2018

In March 2018 the Producer Price Index (PPI) for Industrial Products decreased by 0.9 percent over February 2018, while the index increased by 6.5 percent compared to March 2017.

In March prices for **manufactured products** decreased by 0.9 percent **compared to the previous month**, which resulted in a -0.71 percentage point contribution to the overall monthly PPI change. Lower prices were registered for food products, beverages and tobacco (-1.1 percent), also for chemicals, chemical products and man-made fibers (-3.8 percent).

Prices decreased for **products from mining and quarrying** (-1.7 percent) and for **electrical energy, gas, steam and hot water** (-0.7 percent).

The **annual PPI** was mainly affected by price changes for the following products:

- Manufactured products: prices increased by 5.5 percent, contributing 4.48 percentage points to the overall annual index growth. There was an increase in the prices for food products, beverages and tobacco (5.3 percent), also for basic metals and fabricated metal products (11.8 percent);
- Electrical energy, gas, steam and hot water: prices increased by 12.1 percent and contributed 1.67 percentage points to the overall PPI change;

The following table presents the Producer Price Index over February 2018 and March 2017, with the relevant contributions of the products to the changes in the overall index.






