## PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA OCTOBER 2019

Producer Price Index for Industrial Products decreased by 0.3 percent compared to September 2019, while compared to the corresponding month of the preceding year the index growth amounted to 9.2 percent.

The prices for manufactured products fell by 0.4 percent compared to the previous month, resulting in a -0.35 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price decrease was registered for basic metals and fabricated metal products (1.8 percent).

For **electrical energy, gas, stream and hot water** prices went up by 1.0 percent, contributing 0.11 percentage points to the overall monthly index growth.

The **annual PPI** rate was mainly affected by price changes for the following products:

- Manufactured products: the prices increased by 9.7 percent, contributing 7.88 percentage points to the overall annual index growth. There was an increase in the prices for food products, beverages and tobacco (10.5 percent), pulp, paper and paper products (38.2 percent), also for basic metals and fabricated metal products (6.8 percent);
- **Products from mining and quarrying:** the prices increased by 16.7 percent, contributing 1.09 percentage points to the overall annual index growth;
- Electrical energy, gas, steam and hot water: the prices went up by 2.0 percent and contributed 0.27 percentage points to the overall annual PPI change.

The following table presents the Producer Price Index (compared to the previous month and the corresponding month of the previous year) and the relevant contributions of the products to the changes in the overall index.




#### PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS

(THE SAME MONTH OF THE PREVIOUS YEAR =100)


