
### THE DOMESTIC EXPORTS IN 2019

In 2019 the exports of Georgia (excluding non-declared exports) equaled USD 3 771.5 million, 12.4 percent higher year-on-year. Share of the domestic exports in total export constituted 62.4 percent and amounted to USD 2 352.3 million, 5.7 percent higher year-on-year.

### **GENERAL DATA ON EXTERNAL TRADE OF GEORGIA IN 2014-2019**



In 2019 the domestic exports from Georgia to the EU countries stood at USD 736.6 million, 17.2 percent higher compared to 2018 and reached 31.3 percent in total domestic exports.

In 2019 the exports from Georgia to the EU countries amounted to USD 825.7 million (13.0 percent higher compared to 2018) and constituted 21.9 percent of total exports

In 2019 the domestic exports to the CIS countries stood at USD 855.2 million (10.0 percent higher compared to 2018) and reached 36.4 percent of total domestic exports.

In 2019 the exports to the CIS countries stood at USD 2 003.1 million (20.0 percent higher compared to 2018) and reached 53.1 percent of total exports.

In 2019 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 76.2 percent. The top partners were Russia (USD 432.3 million), Bulgaria (USD 281.6 million) and China (USD 207.0 million).

In 2019 copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 651.6 million, or 27.7 percent of total exports. The exports of ferroalloys totaled USD 302.1 million and their share in the total exports amounted to 12.8 percent. The wines exports occupied the third place standing at USD 221.6 million and constituting 9.4 percent of the total exports.

- 5. According to the international methodology, there are some difference in coverage of trade flows between external merchandise trade statistics and customs statistics. Diplomatic, temporary, transit and analogous goods are excluded from the database of external merchandise trade statistics.

The information is based on the database of LEPL Service Revenue Service. Geostat does not undertake control and adjustment of customs regimes in these databases. For this reason, "domestic exports" in this review do not imply only the export of goods to the domestic produce and the export of foreign origin is also reflected.
