PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA FEBRUARY 2020

Producer Price Index for Industrial Products decreased by 0.3 percent compared to the previous month, while compared to February 2019 the index growth amounted to 6.7 percent.

The prices for **manufactured products** decreased by 0.4 percent **compared to the previous month**, resulting in a -0.32 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price decrease was registered for beverages (-1.3 percent) and for basic metals (-1.7 percent).

The annual PPI rate was mainly affected by price changes for the following products:

- Manufactured products: the prices increased by 7.0 percent, contributing 5.71 percentage points to the overall annual index growth. There was an increase in the prices for food products (12.6 percent);
- **Products from mining and quarrying:** the prices increased by 19.7 percent, contributing 1.24 percentage points to the overall annual index growth;
- Electricity, gas, steam and air conditioning: the prices decreased by 2.4 percent with a relevant contribution of -0.26 percentage points on the annual index change.






PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS
