PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA

MAY 2020

In May 2020 the Producer Price Index for Industrial Products increased by 1.4 percent compared to the previous month, while compared to May 2019 the index growth amounted to 12.7 percent.

The prices for **manufactured products** were 1.6 percent higher **compared to the previous month**, resulting in a 1.27 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price increases were registered for beverages (1.5 percent), chemicals and chemical products (7.3 percent) and basic metals (5.1 percent).

The **annual PPI** rate was mainly affected by price changes for the following products:

- **Manufactured products:** the prices increased by 11.6 percent, contributing 9.62 percentage points to the overall annual index growth. There was a notable increase in the prices for the following subgroups: food products (13.3 percent), beverages (10.2 percent) and basic metals (12.0 percent);
- **Products from mining and quarrying:** the prices were 29.7 percent higher, contributing 1.73 percentage points to the overall annual index growth;
- **Electricity, gas, steam and air conditioning:** the annual price increase amounted to 15.4 percent, which contributed 1.35 percentage points to the annual index growth.

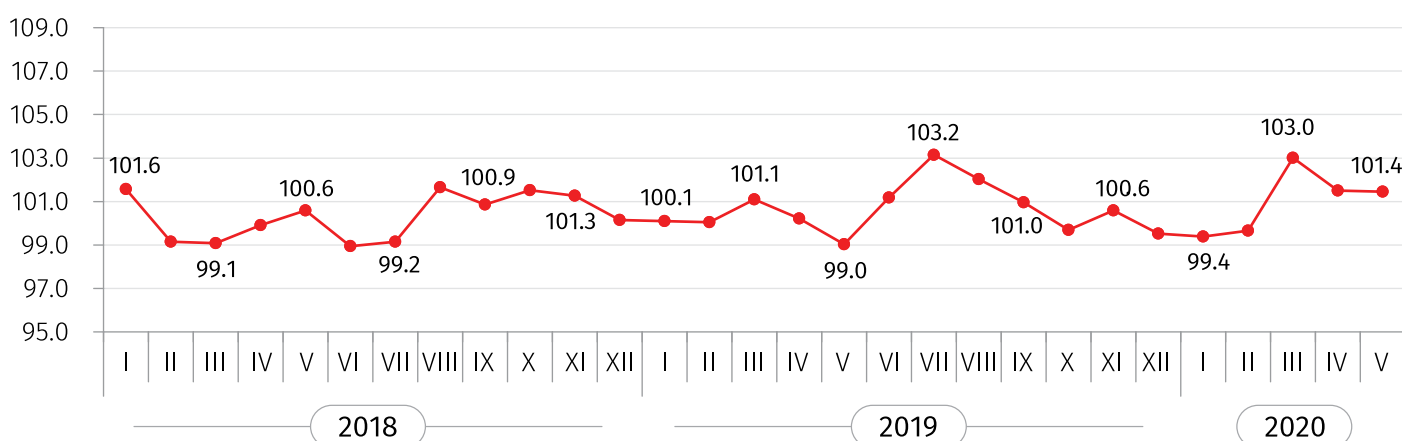

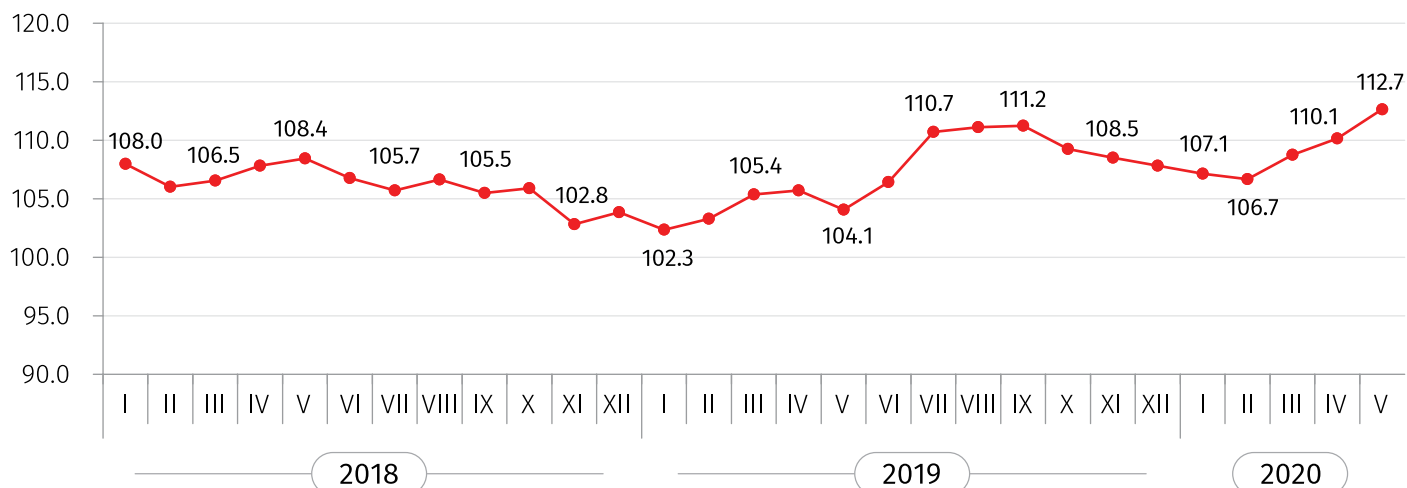

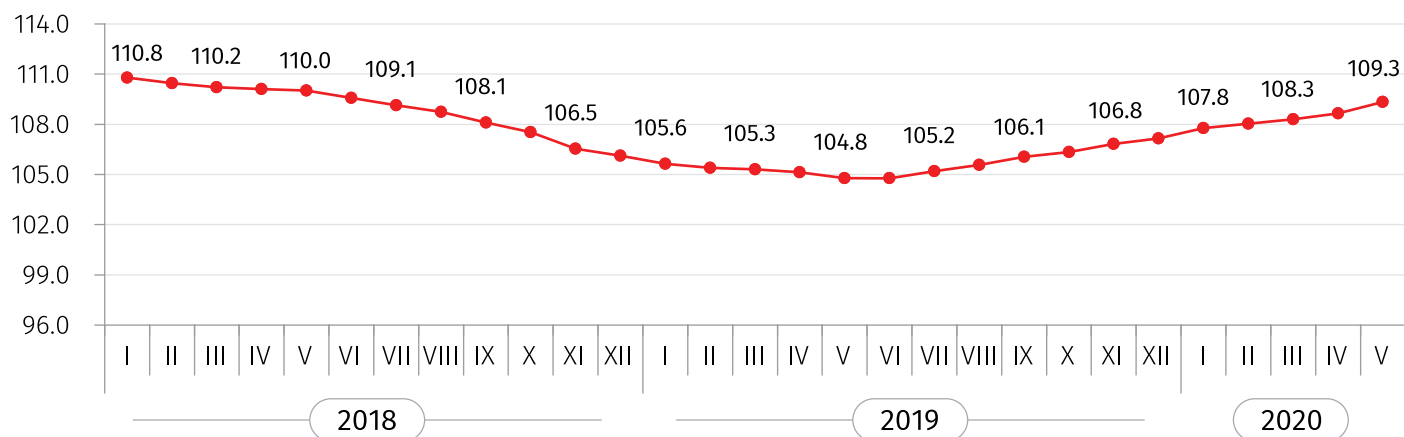
