PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA

JUNE 2020

In June 2020 the Producer Price Index for Industrial Products decreased by 1.2 percent compared to the previous month, while compared to June 2019 the index growth amounted to 10.1 percent.

The prices for **manufactured products** were 0.8 percent lower **compared to May 2020**, resulting in a -0.66 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price decreases were registered for beverages (-2.4 percent), also for rubber and plastic products (-4.0 percent). In the same period the prices decreased also for electricity, gas, steam and air conditioning by 4.5 percent, contributing -0.43 percentage points to the monthly index change.

The **annual PPI** rate was mainly affected by price changes for the following products:

- Manufactured products: the prices increased by 9.8 percent, contributing 8.05 percentage points to the overall annual index growth. There was a notable increase in the prices for the following subgroups: food products (12.4 percent), basic metals (11.2 percent), other non-metallic mineral products (12.6 percent) and beverages (6.3 percent);
- **Products from mining and quarrying:** the prices were 24.5 percent higher, contributing 1.44 percentage points to the overall annual index growth. Within the group the prices were higher for metal ores (45.1 percent);
- Electricity, gas, steam and air conditioning: the annual price increase amounted to 8.1 percent, which contributed 0.69 percentage points to the annual index growth.
