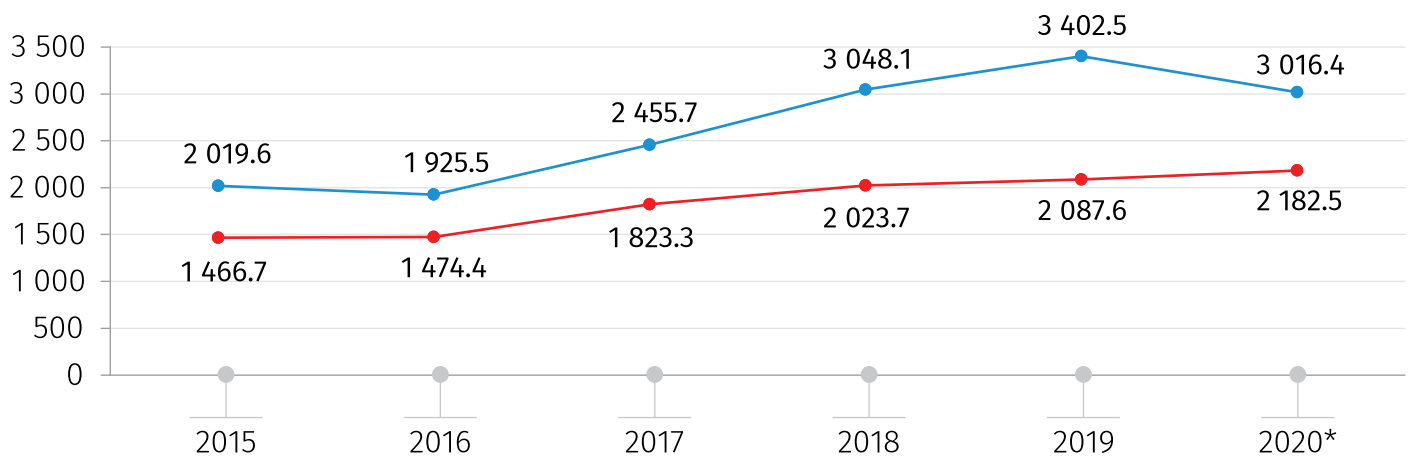

**THE DOMESTIC EXPORTS
IN JANUARY-NOVEMBER 2020**

In January-November 2020 the exports of Georgia (excluding non-declared exports) equaled USD 3 016.4 million, 11.3 percent lower year-on-year. Share of the domestic exports in total export constituted 72.4 percent and amounted to USD 2 182.5 million, 4.5 percent higher to the January-November 2019.

(MILL. USD)**



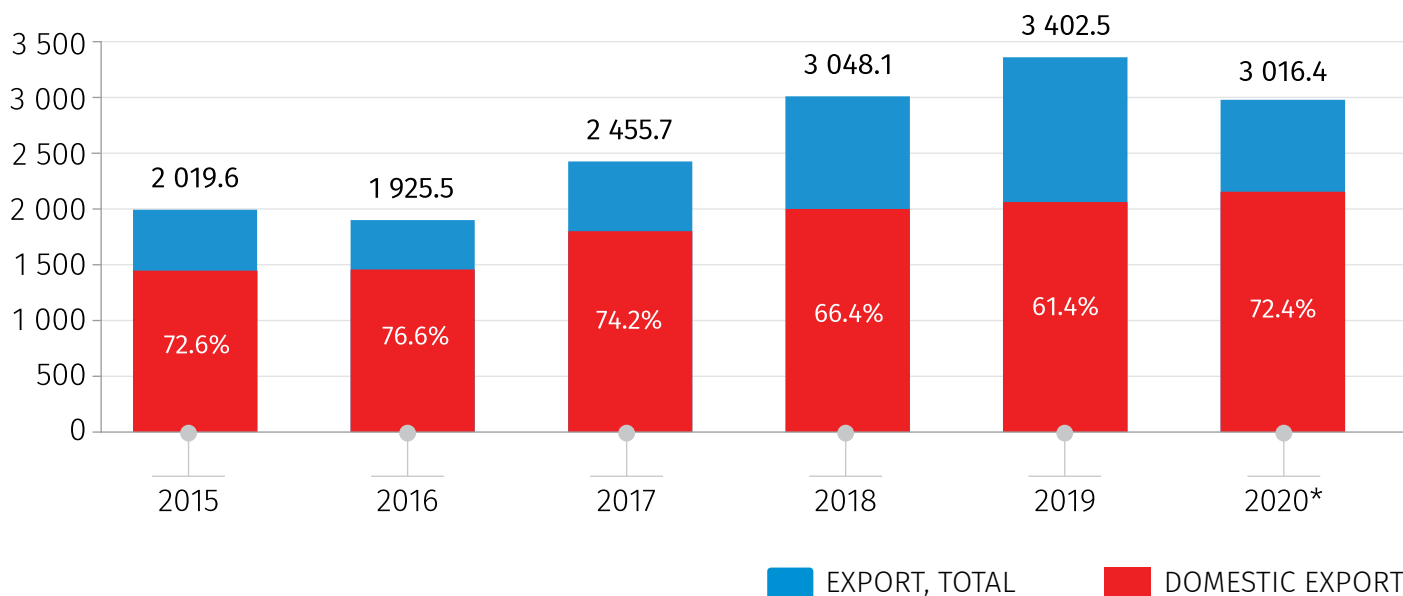

In January-November 2020 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 79.1 percent. The top partners were China (USD 431.2 million), Russia (USD 360.3 million) and Bulgaria (USD 281.0 million).

In January-November 2020 copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 677.2 million, or 31.0 percent of total exports. The exports of ferro-alloys totaled USD 231.0 million and their share in the total exports amounted to 10.6 percent. The exports of wine of fresh grapes occupied the third place standing at USD 185.3 million and constituting 8.5 percent of the total exports.

Domestic exports include export of goods produced in the country, as well as imported from abroad, the value of which has significantly changed as a result of domestic processing.
