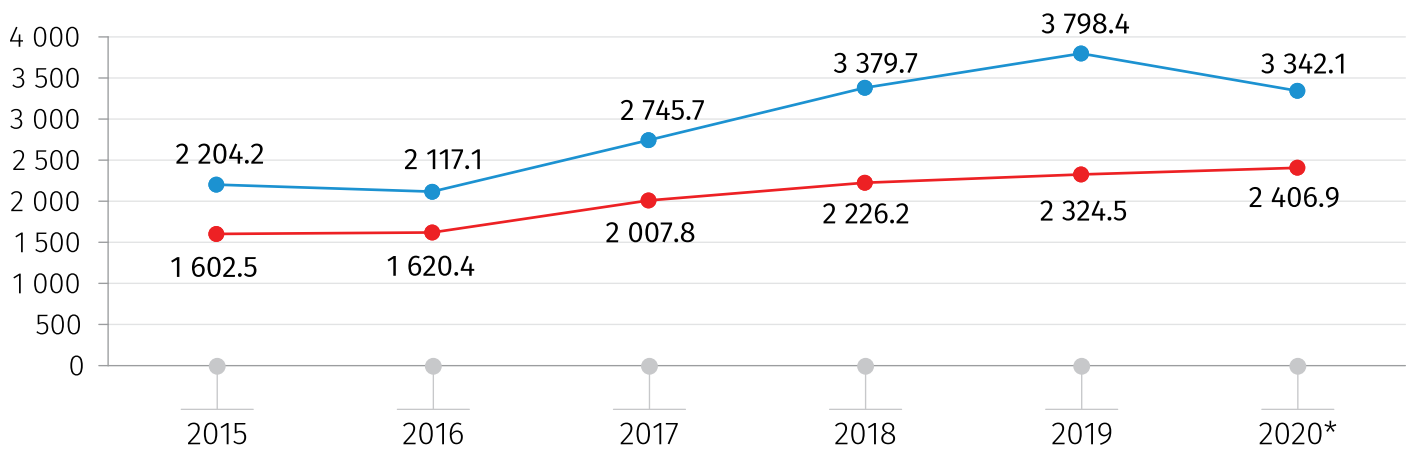

THE DOMESTIC EXPORTS IN 2020

In 2020 the exports of Georgia (excluding non-declared exports) equaled USD 3 342.1 million, 12.0 percent lower year-on-year. Share of the domestic exports in total export constituted 72.0 percent and amounted to USD 2 406.9 million, 3.5 percent higher year-on-year.

(MILL. USD)



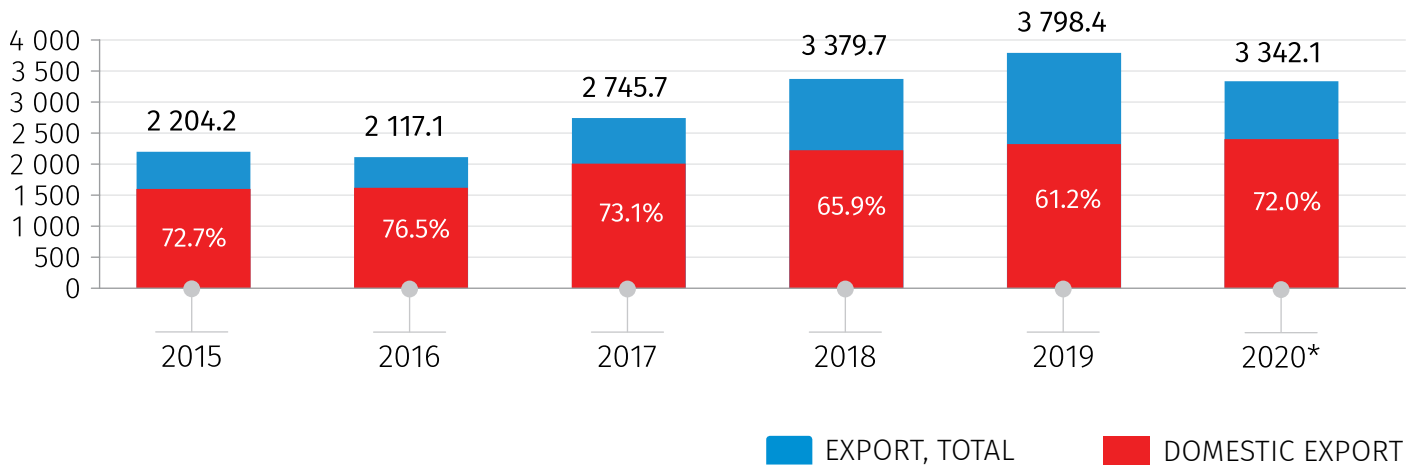

In 2020 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 78.6 percent. The top partners were China (USD 459.4 million), Russia (USD 401.2 million) and Bulgaria (USD 310.4 million).

In 2020 copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 729.4 million, or 30.3 percent of total exports. The exports of ferro-alloys totaled USD 246.8 million and their share in the total exports amounted to 10.3 percent. The exports of wine of fresh grapes occupied the third place standing at USD 209.0 million and constituting 8.7 percent of the total exports.
