PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA APRIL 2021

In April 2021 the Producer Price Index for Industrial Products increased by 3.2 percent compared to the previous month, while compared to April 2020 the index growth amounted to 17.5 percent.

The prices for **manufactured products** increased by 3.6 percent **compared to March 2021**, resulting in a 2.84 percentage point contribution to the overall monthly PPI change. Within the group noteworthy price increases were registered for food products (2.2 percent) and basic metals (12.2 percent). In the same period the prices for **products from mining and quarrying** increased by 5.6 percent, contributing 0.35 percentage points to the monthly index change. The prices increased for **electricity, gas, steam and air conditioning** by 0.5 percent, contributing 0.06 percentage points to the monthly index change.

The **annual PPI** rate was mainly affected by price changes for the following products:

• **Products from mining and quarrying:** the prices were 17.8 percent higher, contributing 0.9 percentage points to the overall annual index change. Within the group the prices were higher for metal ores (16.4 percent);

• **Manufactured products:** the prices increased by 16.7 percent, contributing 13.47 percentage points to the overall annual index growth. There was a notable increase in the prices for the following subgroups: food products (16.8 percent), beverages (7.7 percent) and basic metals (37.7 percent);

• **Electricity, gas, steam and air conditioning:** the annual price increase amounted to 19.8 percent, which contributed 2.27 percentage points to the annual index growth;

• Water supply, sewerage, waste management and remediation services: the annual price increase amounted to 30.1 percent, which contributed 0.83 percentage points to the annual index growth.




PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS

(THE SAME MONTH OF THE PREVIOUS YEAR =100)


