ACTIVITIES OF ENTERPRISES

II QUARTER, 2021

In the II quarter of 2021 compared to the same quarter of previous year the volume of business sector turnover increased by 56.7 percent and amounted to 35.0 billion GEL.

The production value of the business sector is characterized by the inreasing tendency. In the I quarter of 2021, its volume equaled to 13.2 billion GEL, which is year-on-year 43.4 percent more:

CHANGE IN THE VOLUME OF BUSINESS SECOTRE TURNOVER AND PRODUCTION VALUE BY QUARTERS





In the II quarter of 2021, 61.4 percent of total turnover comes on large and 18.2 percent – on medium businesses while 20.4 percent is distributed to small business.

A small difference is in case of total production value: 45.9 percent comes on large, 27.1 percent – on medium and 27.0 percent on small businesses.

BUSINESS SECTOR TURNOVER AND PRODUCTION VALUE BY SIZE OF ENTERPRISES, II QUARTER, 2021




In II quarter of 2021, total purchases of goods and services carried out by enterprises equaled to 19.2 billion GEL (year-on-year 48.5 percent more), while the purchase goods and services for resale amounted 11.8 billion GEL (year-on-year 52.0 percent more).

In the II quarter of 2021, the average number of employees equaled to 659.7 thousand, which is year-on-year 4.4 percent more. Out of the total number of employees, 42.0 percent are female and 58.0 percent are male.

40.6 percent of total number of employees comes on large, 22.6 percent – on medium and 36.8 percent - on small businesses.

The total number of employed persons amounted 623.7 thousands (year-on-year 4.0 percent more). The total personnel costs of enterprises equaled to 2 648.3 million GEL (year-on-year 22.9 percent more).

In the II quarter of 2021, average monthly remuneration of employed persons equaled to 1 389.6 GEL (year-on-year increase by 214.0 GEL) while remuneration of employed women made up 1 098.4 GEL (year-on-year increase by 182.1 GEL). Average monthly remuneration of employed persons by size of enterprises is as follows:


- LARGE BUSINESS 1 440.3 GEL
- MEDIUM BUSINESS 1 640.4 GEL
- SMALL BUSINESS 1 144.9 GEL

In the II quarter of 2021, the trade sector (including repair of motor vehicles and motorcycles) has the highest share (36.8 percent) in the total turnover in business sector, followed by arts, entertainment and recreation with 31.6 percent share, manufacturing – 10.2 percent, construction – 5.7 percent, transportation and storage – 4.7 percent, electricity, gas, steam and air conditioning supply – 2.8 percent and other sectors with 8.2 percent share:

TURNOVER IN BUSINESS SECTOR, II QUARTER, 2021



In the II quarter of 2021, manufacturing (25.1 percent), trade (19.2 percent), construction (16.2 percent), and transportation and storage (9.0 percent) are on the top four places in business sector production value. Rest of sectors have the 30.5 percent share:

PRODUCTION VALUE IN BUSINESS SECTOR, II QUARTER, 2021



In the II quarter of 2021, trade (wholesale and retail trade, repair of motor vehicles and motorcycles), manufacturing and Human health and social work activities are leading in business sector by number of employees (accordingly with 27.4 percent, 13.1 percent and 11.0 percent share). However, construction activities (8.8 percent), Enterprises engaged in transportation and storage (8.0 percent) and Accommodation and food service activities (4.6 percent) have also a significant share:


NUMBER OF EMPLOYEES IN BUSINESS SECTOR, II QUARTER, 2021


By regions, Tbilisi and following regions are leading in **gross turnover**:

- Adjara 3.8 percent
- Imereti 4.1 prcent
- Samegrelo-Zemo svaneti 2.3 percent

By regions, Tbilisi and following regions are still leading in gross **production value**:

- Tbilisi 62.0 percent
- Adjara 8.7 percent
- Kvemo Kartli 8.3 percent
- Imereti 6.8 prcent
- Samegrelo-Zemo svaneti –3.6 percent

The chart bellow shows turnover and production value by region, except Tbilisi (in mln GEL):




