Instruction

During the interview, the household member/members who are informed about the amount of expenditures in the field of education shall be interviewed. Expenditure on education includes only the costs paid in the form tuition fees. Other additional costs, which may be pay by household (for example: school inventory or training materials) doesn't not belong to the category of education expenses and will not be recorded in the questionnaire.

The questionnaire consists of two parts. The first part of the questionnaire includes the following information about the household member/members receiving education in 2019: name, surname, gender, age, and education received in 2019. The codes given in the first part of the questionnaire are used to determine the gender and the level of education received.

The second part of the questionnaire includes the expenditures on education in 2019 according to the following levels of education:

- 1. **Pre-school education in private kindergartens** includes expenses incurred in the form of payment only in private kindergartens. This level does not include spending on other extra classes in kindergartens or expenditures for other purposes.
- 2. **Primary Secondary education in private schools** includes the cost of primary, basic and secondary education in private schools and does not include expenses on extra classes in School or expenses for other purposes.
- 3. **Technical and vocational education** includes expenses for the following categories of education: short vocational programs, services of driving schools, services of language schools, services of information technology schools, etc. It also includes the cost of online training for technical and vocational education.
- 4. **Higher education** includes university tuition fees, including bachelor's, master's and doctoral degrees.
- 5. **Education in the fields of sports, recreation and culture** includes services in the field of sports, recreation and culture education. For example: camping services with sports training, gymnastics training services, yoga training services, equestrian training services, dance and music schools and teachers services, fine arts schools and teachers services, etc.
- **6. Educational Support Activities -** includes non-educational services designed to support educational processes or systems.
- 7. Educational Service of Private Tutor
- 8. Educational Service of Preparatory Center
- 9. Education Abroad

The second part of the questionnaire includes the expenditures on education in 2019 according to the sources of funding:

- 1. **Private person** is a private person, recipient of the education himself/herself, his/her family member or other sponsors, which does not belong to the other source of funding given in the questionnaire.
- 2. **Private company** a company registered as a legal entity.
- 3. International / non-governmental organization

- 4. **State** includes funding for both central and local municipalities.
- 5. **Other sponsors (please indicate)** Other sources of funding that do not fall in the above categories.
- 6. **Expenses incurred by another sponsor** Expenditures incurred by another sponsor.

In case the respondent is unable to determine expenditures on education, the note: "-" should be indicated in the appropriate field of the source of funding.
