## 3. Statistical presentation

#### 3.1. Data description

The following indicators are published within the survey of enterprises engaged in postal and courier activities:

- 1. Income from postal and courier activities;
- 2. Average number of employees;
- 3. Number of transfers;

between them:

- Written Correspondence;
- Parcels.

The data are published at the country level.

#### 3.2. Classification system

The survey covers the enterprises whose economic activities are related to the Section H (Post and Courier Activities) of the National Classification of Economic Activities (NACE Rev.2).

# 3.3. Sector coverage

Survey covers only enterprises engaged in postal and courier activities only.

#### 3.4. Statistical concepts and definitions

**Active Enterprise** – all non-financial corporations that were active (Income from the sale of goods and services is accrued during the year and / or remuneration is accrued to employees) during the reporting period.

**Local unit** – all separate part of the enterprise (branch) which was active during the reporting period.

**Income** – Accrued incomes, from the sale of services by enterprises engaged in postal and courier activities, without VAT and excise.

**Average annual number of persons employed** – average number of persons employed (employees, employed shareholders and employed family members in case of family owned enterprise) in enterprise during the year.

**Number of postal and courier items** – number of postal and courier items (written correspondence, parcel, EMS and AVIA message received and / or delivered by the enterprise) delivered.

**Written correspondence** – number of written correspondences (type of items to which the postcard; letter (including hybrid letter); small package and M bag)) (local and international) delivered.

**Parcels** – number of parcels (type of item that may contain any item (goods) provided that sending/receiving it does not conflict with the legislation of legislation, the acts of Universal Post Union and the rules established by the recipient country or by Georgian Post, the weight is up to 30 kg.) delivered (local and international).

Enterprise – the economic unit that produces goods or services, independently makes economic decisions about

distribution of their resources (holds a definite degree of freedom in making decision). The enterprise carries out one or more of the economic activities according to one or more locations. The enterprise may be individual (physical) or legal entity.

### 3.5. Statistical unit

Enterprise.

#### 3.6. Statistical population

All active enterprises engaged in postal and courier activities are represented in business registry. Within the survey, approximately 300 enterprises will be surveyed.

#### 3.7. Reference area

The entire territory of Georgia, except for the occupied regions.

### 7. Confidentiality

### 7.1. Confidentiality – policy

- 1. The Law of Georgia on Official Statistics:
  - According to the article 4 of the law individual data collected by statistical agencies for statistical compilation, whether they refer to natural or legal persons, are to be strictly confidential and used exclusively for statistical purposes.
  - According to the article 28 (Observing Confidentiality of Statistical Data) of the law 1. The data collected for the purpose of producing official statistics shall be confidential if it allows for identification of observation unit or r it is possible to identify such data through it. 2. The confidential statistical data shall not be issued or disseminated or used for a non-statistical purpose but for the exceptions envisaged by the Georgian legislation.

    3. When producing the official statistics, it is obligatory to destroy or store separately the identity data
    - including the questionnaires containing such data and used for statistical surveys according to the rules defined in the Georgian legislation.
  - According to the article 29 (The Obligations and Responsibilities of the Employees of the Geostat) of the law the confidential statistical data collected and processed for the purpose of statistical survey shall not be used or disseminated by the employees of the units of the Geostat.
