

THE DOMESTIC EXPORTS IN 2022

In 2022 the exports of Georgia (excluding non-declared exports) equaled USD 5 592.8 million, 31.8 percent higher year-on-year. Share of the domestic exports in total export constituted 66.2 percent and amounted to USD 3 704.2 million, 18.4 percent higher compared to 2021.

(MILL. USD)



In 2022 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 80.1 percent. The top partners were China (USD 694.8 million), Russia (USD 536.1 million) and Bulgaria (USD 419.9 million).

TOP TRADING PARTNERS BY DOMESTIC EXPORTS

In 2022 copper ores and concentrates reclaimed the first place in the list of top export items, equaling USD 1 024.3 million, or 27.7 percent of total exports. The exports of ferro-alloys totaled USD 453.3 million and their share in the total exports amounted to 12.2 percent. The exports of nitrogenous fertilizers occupied the third place, standing at USD 281.4 million and constituting 7.6 percent of the total exports.

- 1. The discrepancy between the totals and the sum in some cases can be explained by using rounded data;
- 2. Information does not cover the data of Simplified Customs Declarations (Form №4);

3. Information does not cover non-organized trade, also occupied territories of Abkhazian Autonomous Republic and Tskhinvali region;

4. According to the international methodology, there are some differences in coverage of trade flows between external merchandise trade statistics and customs statistics. Diplomatic, temporary, transit and analogous goods are excluded from the database of external merchandise trade statistics.

The preliminary data will be revised according to the Geostat's revision policy (based on the regular revision principle) as a result of adjusting data by respondents/administrative sources.

Domestic exports include export of goods produced in the country, as well as imported from abroad, the value of which has significantly changed as a result of domestic processing.
