In order to calculate <u>the average annual (quarterly) number of employees</u> it is needed to sum up the average number of workers by the months of the reference year (quarter) and divide the sum by 12 (3);

In order to calculate <u>the average monthly number of employees</u> it is needed to sum up the number of employees for each day of the month, i.e. from the first day of the month (or the date from which the organization (establishment) started to work in a given month) including the last day (30st or 31st, in case of February - 28st (29st) or the day till which it worked), holidays and weekends (on holidays and weekends the number of employees is calculated as equal to the previous working day) and divide the sum by the number of calendar days of the reference month.

Part-time day or part-week employees, unless the legislation does not provide otherwise, shall be included in the number of employees in proportion to their actual working time (First of all the man-hours worked out in a month are divided by the standardized length of the working day, and then the number of working days); for example, in an organization (establishment), where the standardized length of the working day is 8 hours, and working days in a month is 21 (in case of five-day working week), if 8 part-time employees worked 840 man-hours, they shall be included in the average monthly number of employees per month not as 8 men, but as a 5 man (840/8/21 = 5).

If in an organization (establishment) regularly employed owners or their family members are paid a salary on a regular basis for their position or performed work, then they are considered as hired, in this case, 01 row.=02 row.
