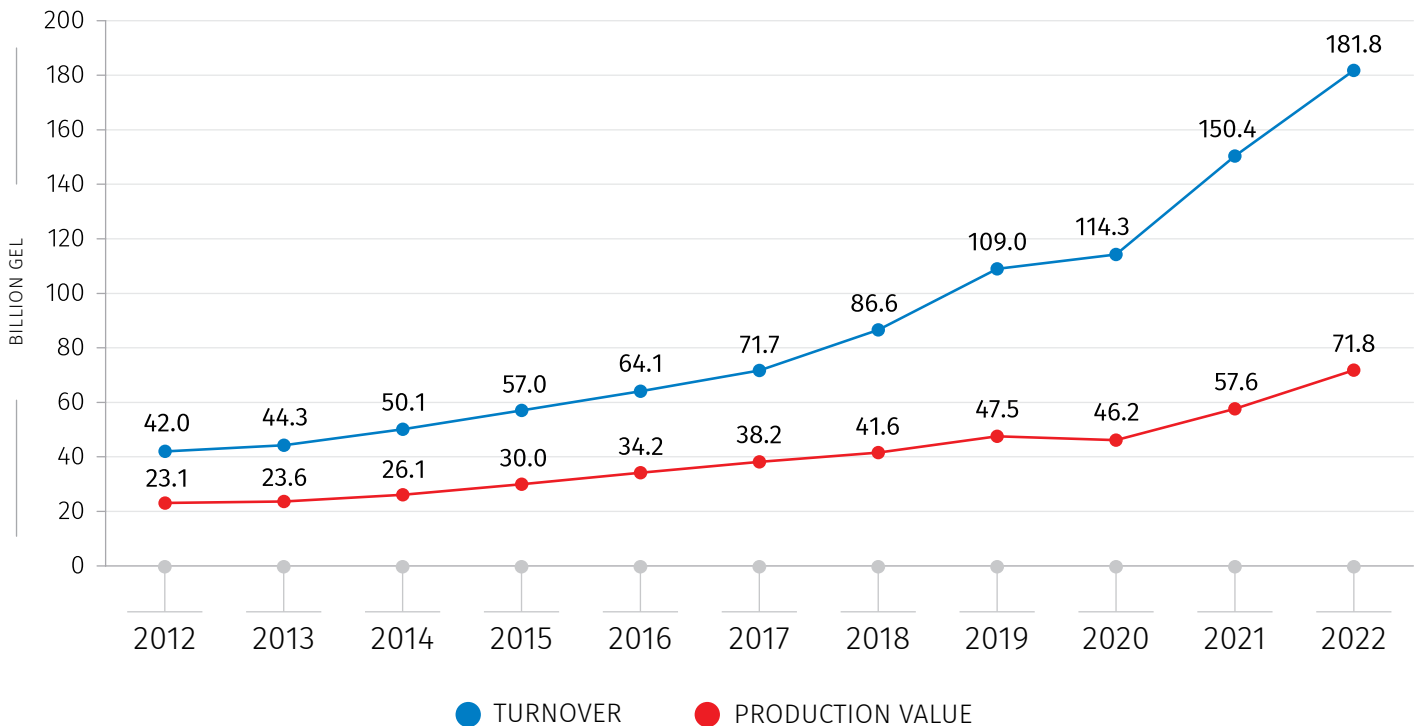

**ACTIVITIES OF ENTERPRISES,
2022**

In the Year 2022 compared to the previous year the volume of business sector turnover increased by 20.8 percent and amounted to 181.8 billion GEL.

The production value of the business sector is characterized by the growth tendency. In the Year 2022, its volume equaled to 71.8 billion GEL, which is year-on-year 24.6 percent higher:

BY QUARTERS**

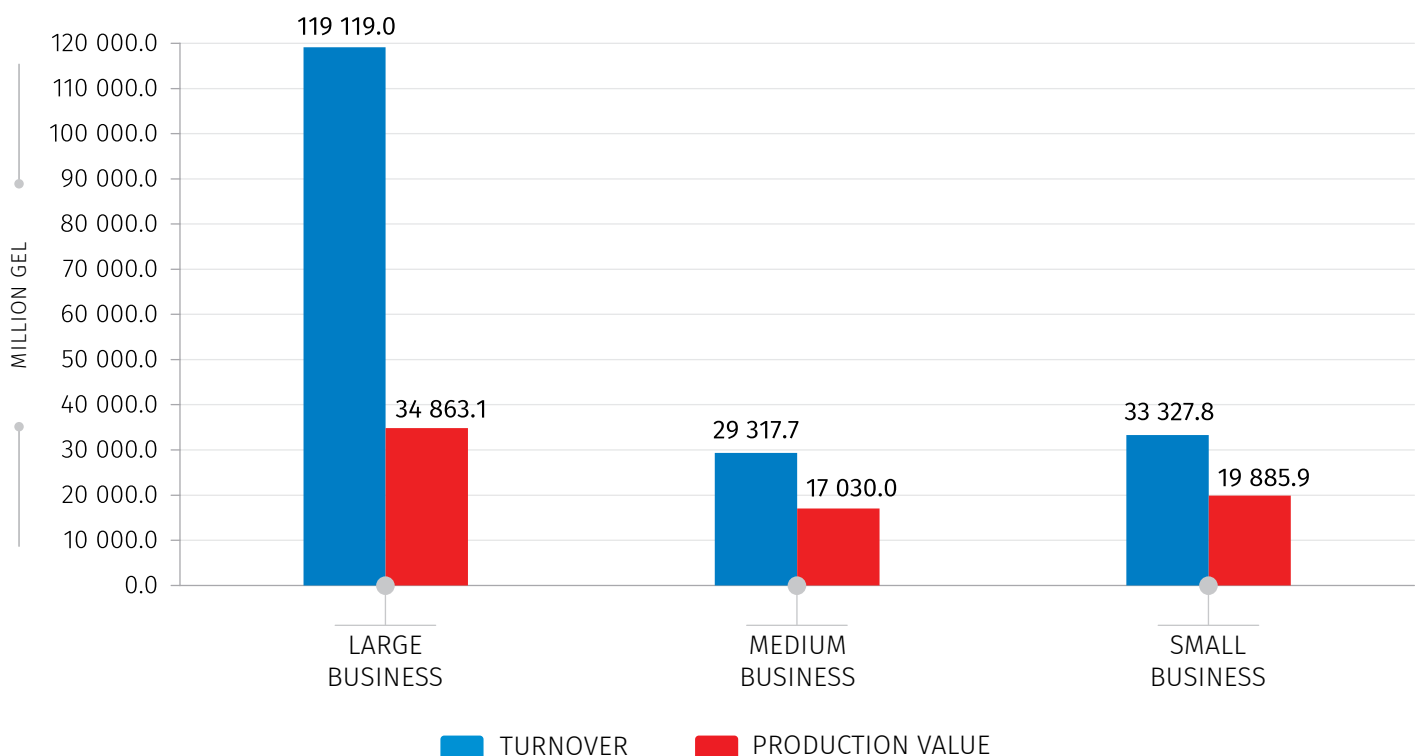

In the Year 2022, 65.5 percent of total turnover comes on large and 16.1 percent - on medium businesses while 18.3 percent is distributed to small business.

A small difference is in case of total production value: 48.6 percent comes on large, 23.7 percent – on medium and 27.7 percent on small businesses.

BY SIZE OF ENTERPRISES, 2022**

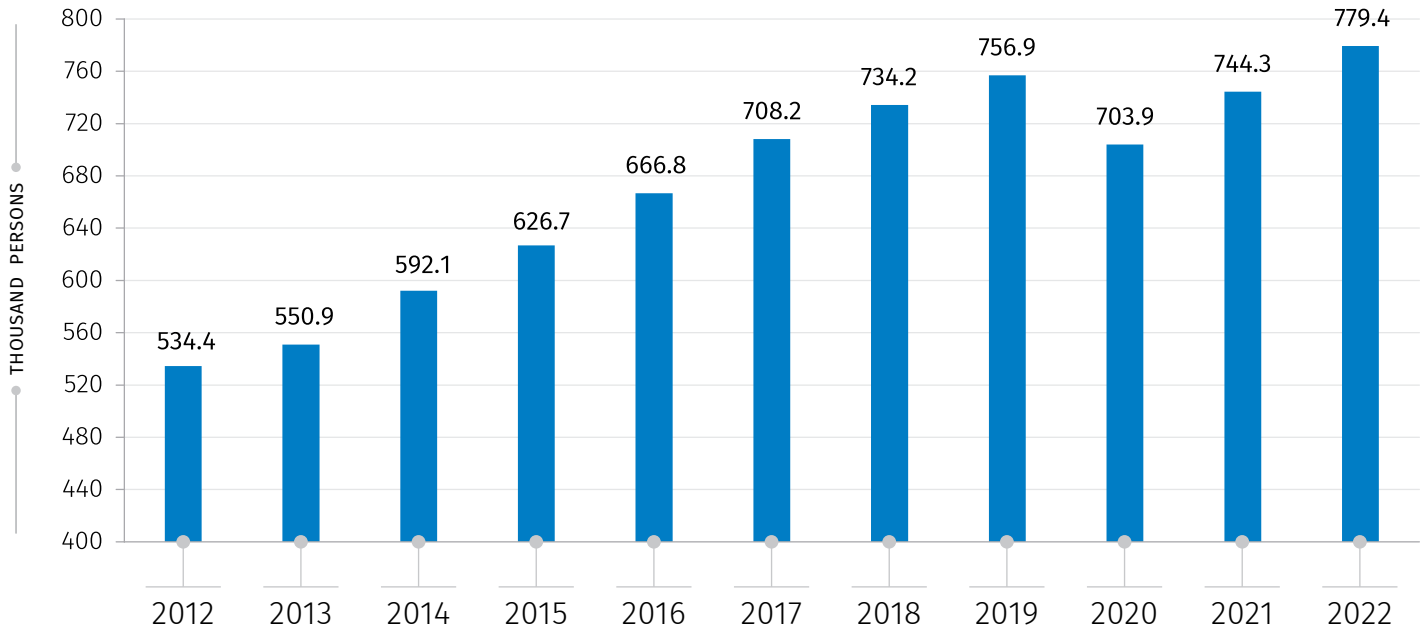


In the Year 2022, total purchases of goods and services carried out by enterprises equaled to 101.4 billion GEL, while the purchase goods and services for resale amounted 65.8 billion GEL. Total purchases of goods and services increased by 24.6 percent, and purchases of goods and services for resale increased by 27.0 percent compared to the previous year.

In the Year 2022, the average number of employees equaled to 779.4 thousand, which is year-on-year 4.7 percent higher. Out of the total number of employees, 43.1 percent are female and 56.9 percent are male.

39.9 percent of total number of employees comes on large, 20.3 percent – on medium and 39.8 percent - on small businesses.

The total number of employed persons amounted 726.2 thousands (year-on-year 5.5 percent higher). The total personnel costs of enterprises equaled to 14 283.9 million GEL (year-on-year 25.8 percent higher).

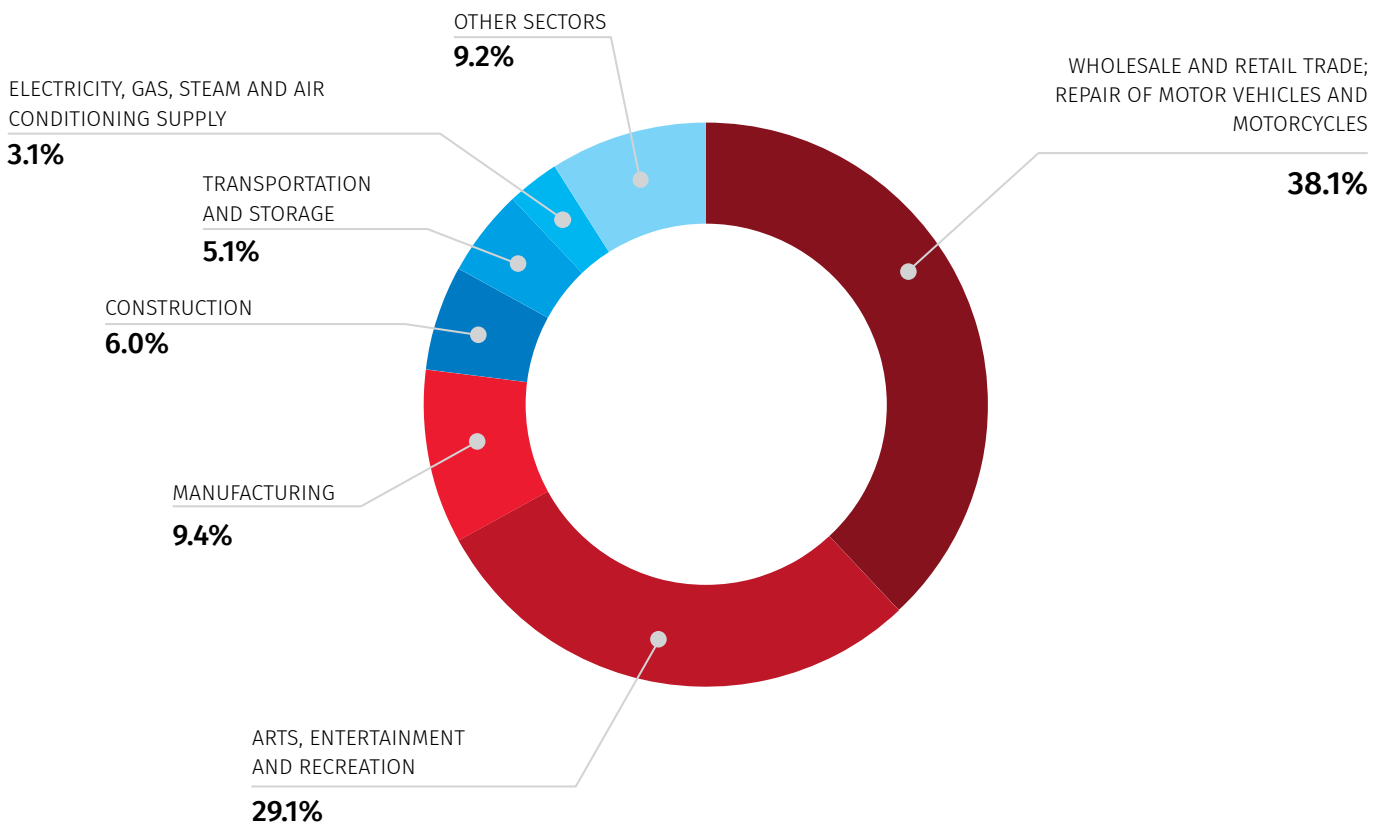
In the Year 2022, average monthly remuneration of employed persons equaled to 1 605.9 GEL (year-on-year increase by 258.3 GEL) while remuneration of employed women made up 1 264.0 GEL (year-on-year increase by 199.6 GEL). Average monthly remuneration of employed persons by size of enterprises is as follows:

- Large business – 1 822.4 GEL
- Medium business – 1 862.2 GEL
- Small business – 1 187.2GEL

In the Year 2022, the trade sector (including repair of motor vehicles and motorcycles) has the highest share (38.1 percent) in the total turnover in business sector, followed by arts, entertainment and recreation with 29.1 percent share, manufacturing – 9.4 percent, construction – 6.0 percent, transportation and storage – 5.1 percent, electricity, gas, steam and air conditioning supply – 3.1 percent and other sectors with 9.2 percent share:

2022

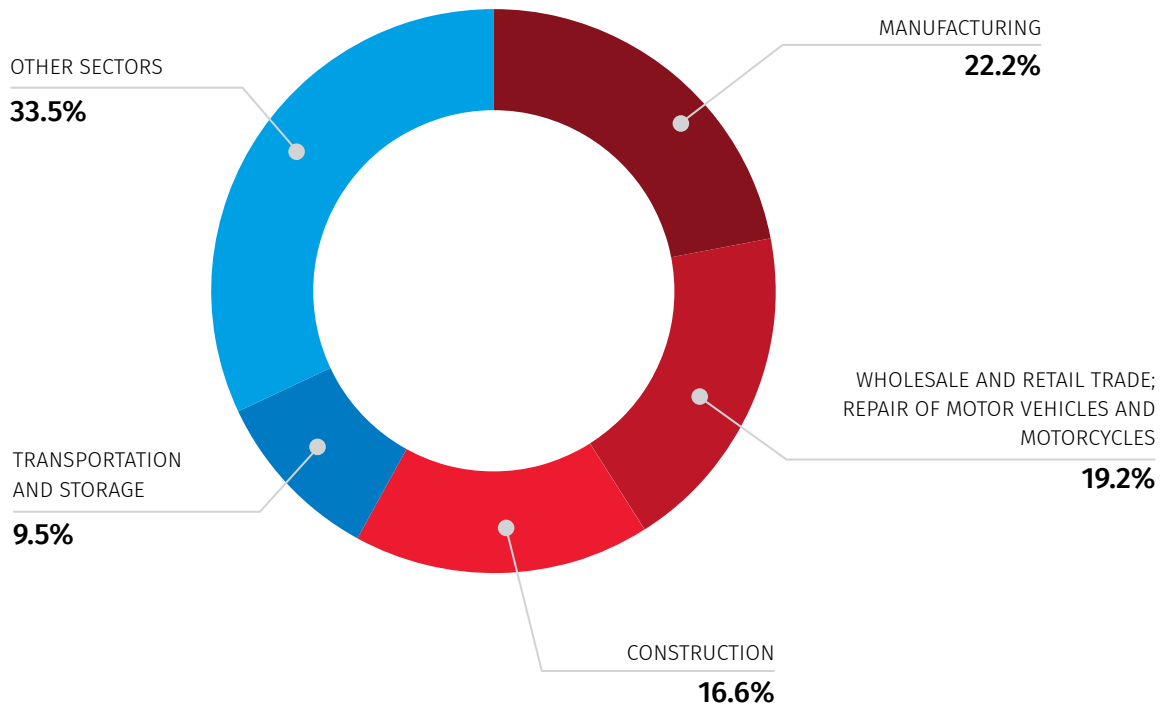

In the Year 2022, manufacturing (22.2 percent), trade (19.2 percent) and construction (16.6 percent) transportation and storage (9.5 percent) are on the top four places in business sector production value. Rest of sectors have the 32.5 percent share:

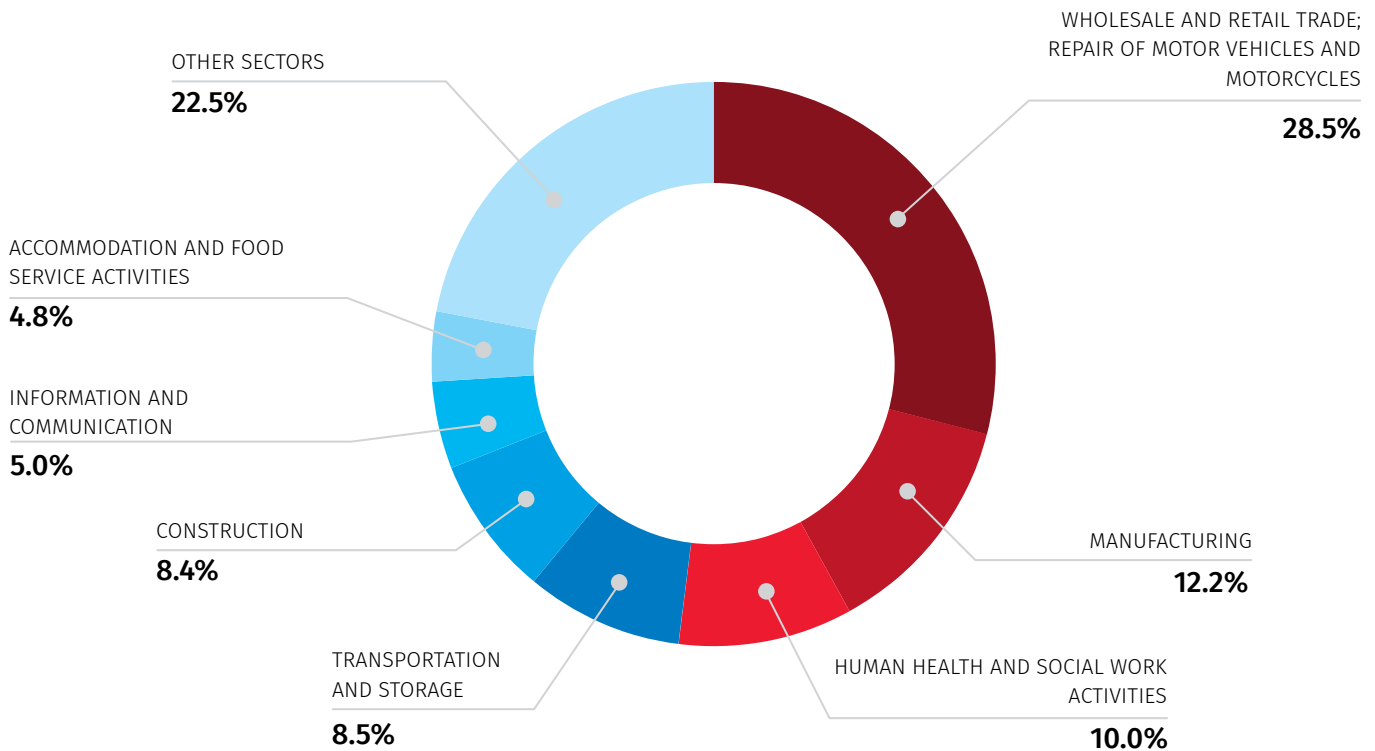
PRODUCTION VALUE IN BUSINESS SECTOR, 2022

In the Year 2022, trade (wholesale and retail trade, repair of motor vehicles and motorcycles), manufacturing and human health and social work activities are leading in business sector by number of employees (accordingly with 28.5 percent, 12.2 percent and 10.0 percent share). However, enterprises engaged in transportation and storage (8.5 percent), construction (8.4 percent), information and communication (5.0 percent) and accommodation and food service activities (4.8 percent) have also a significant share:

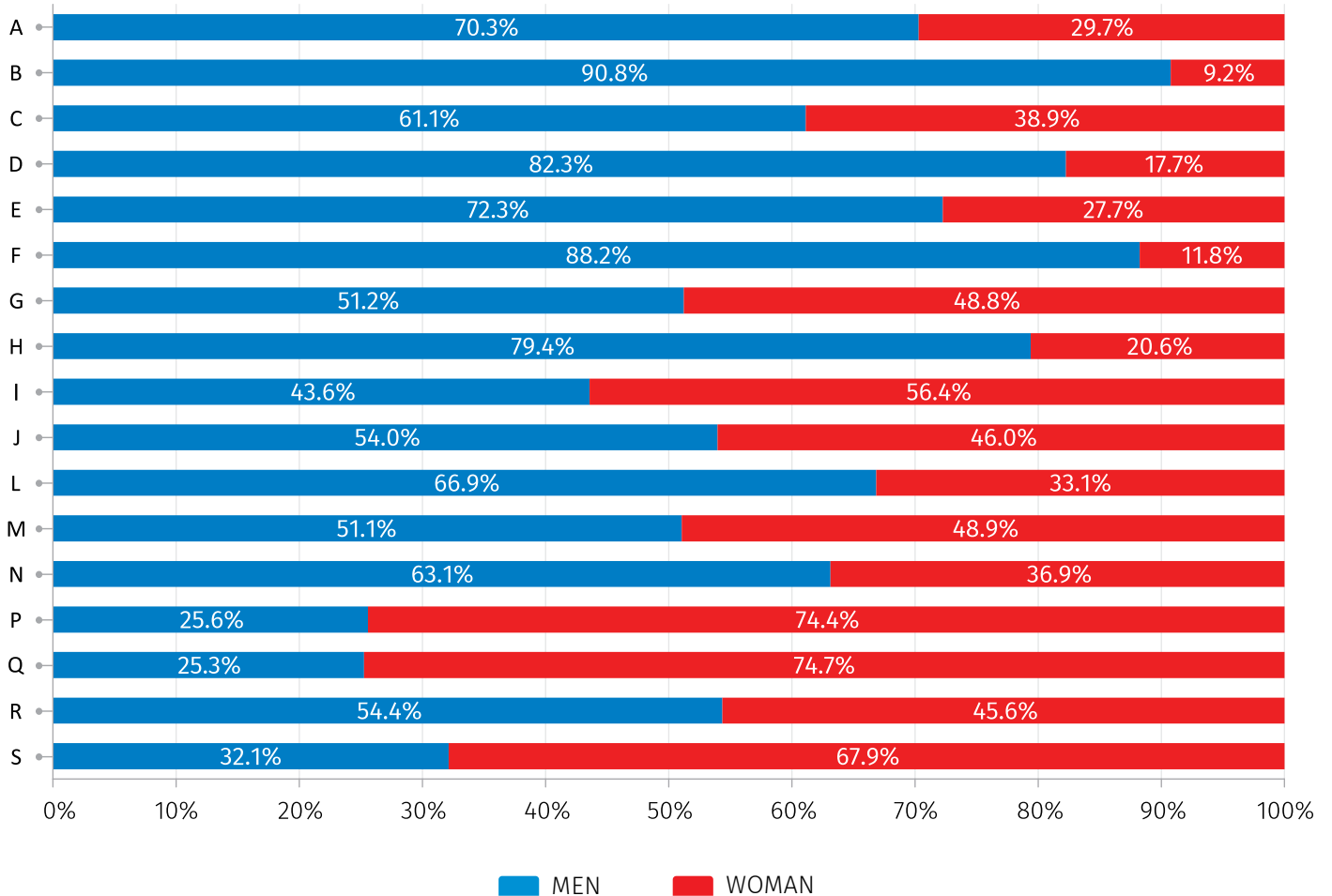
**NUMBER OF EMPLOYEES IN BUSINESS SECTOR,

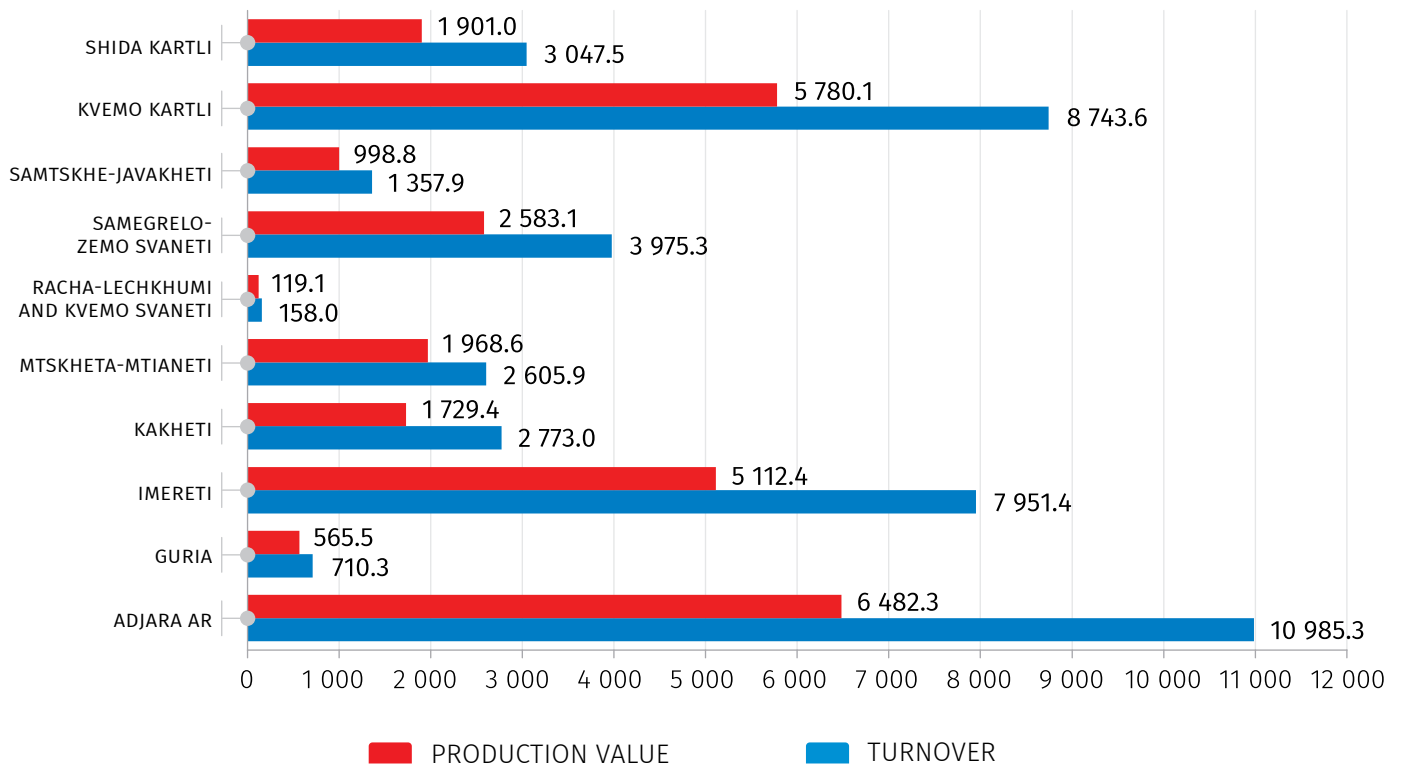
By regions, Tbilisi and following regions are leading in gross turnover:

- Tbilisi – 76.7 percent
- Adjara – 6.0 percent
- Kvemo Kartli – 4.8 percent
- Imereti – 4.4 percent
- Samegrelo-Zemo svaneti – 2.2 percent

By regions, Tbilisi and following regions are still leading in gross production value:

- Tbilisi – 61.9 percent
- Adjara – 9.0 percent
- Kvemo Kartli – 8.1 percent
- Imereti – 7.1 percent
- Samegrelo-Zemo svaneti – 3.6 percent

The chart below shows turnover and production value by region, except Tbilisi (in mln GEL):

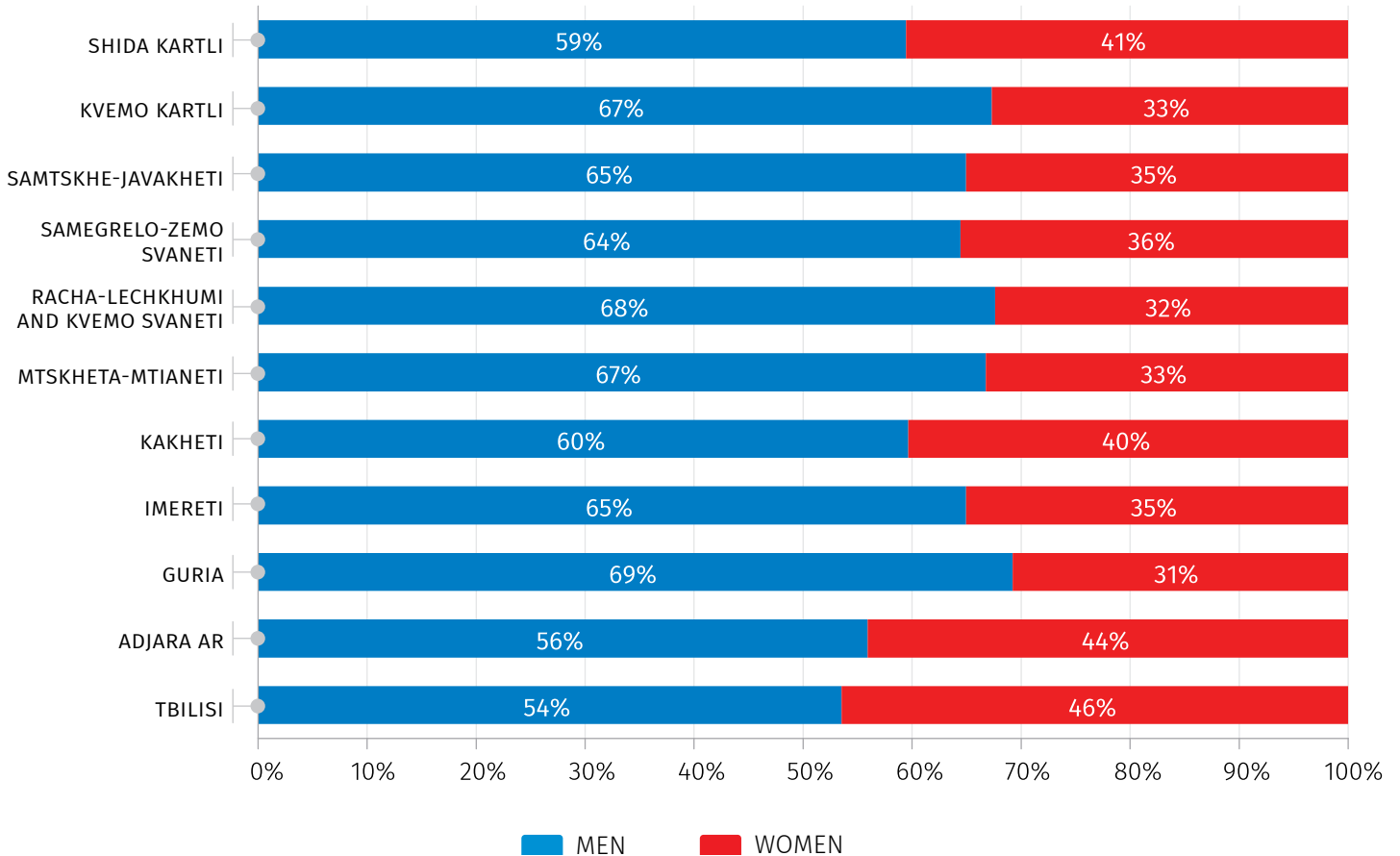
