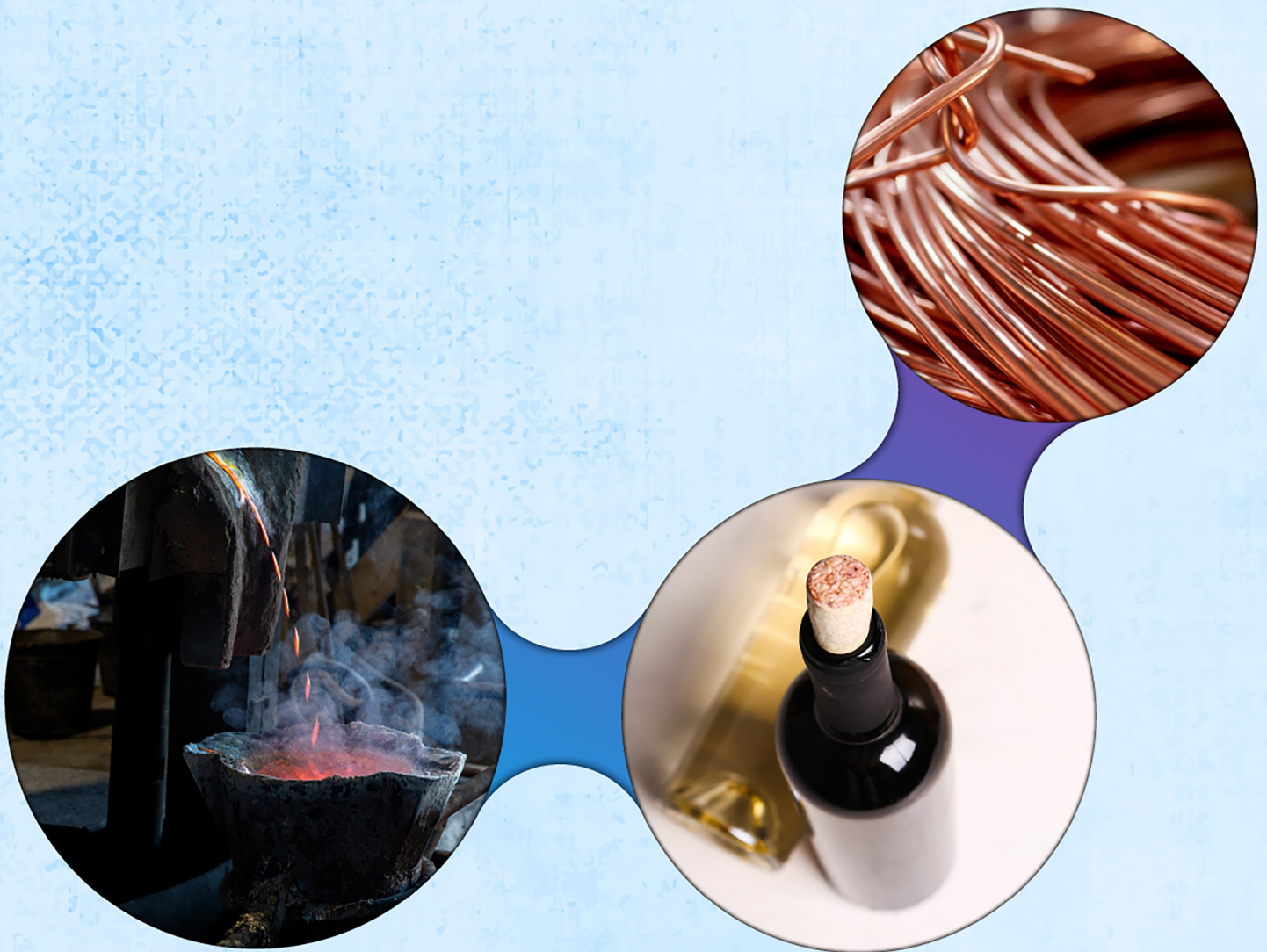

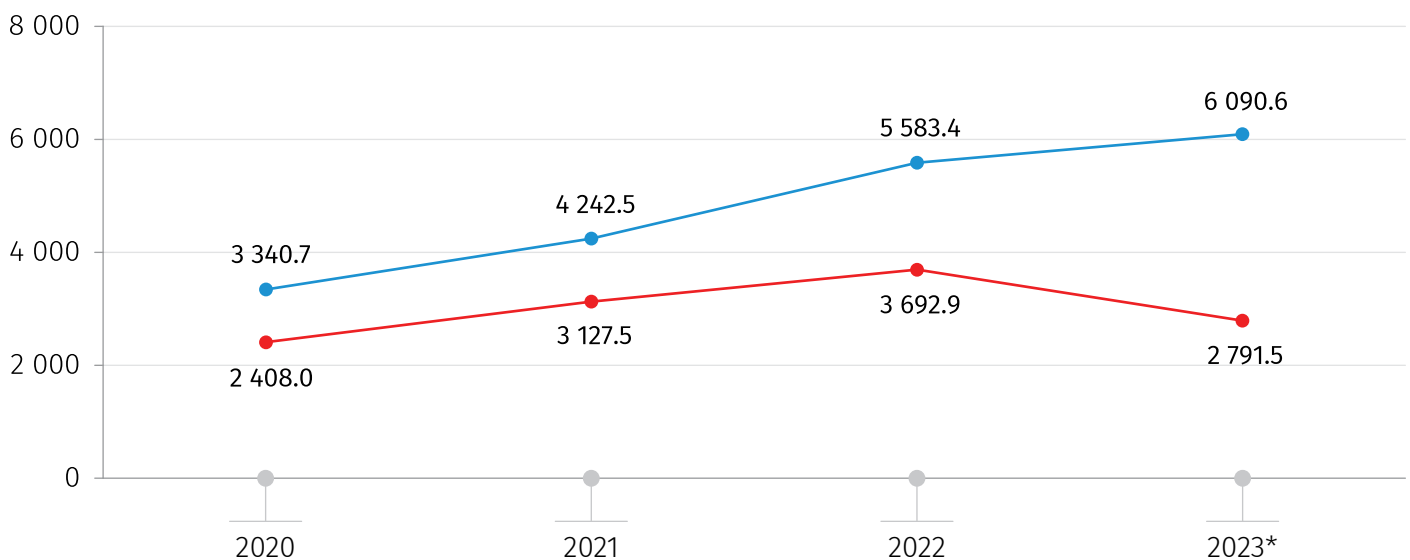

THE DOMESTIC EXPORTS IN 2023 (PRELIMINARY)

In 2023 the exports of Georgia (excluding non-declared exports) equaled USD 6 090.6 million, 9.1 percent higher year-on-year. Share of the domestic exports in total exports constituted 45.8 percent and amounted to USD 2 791.5 million, 24.4 percent lower than in 2022.

TREND OF THE EXPORTS IN GEORGIA IN 2020-2023 (MILL. USD)



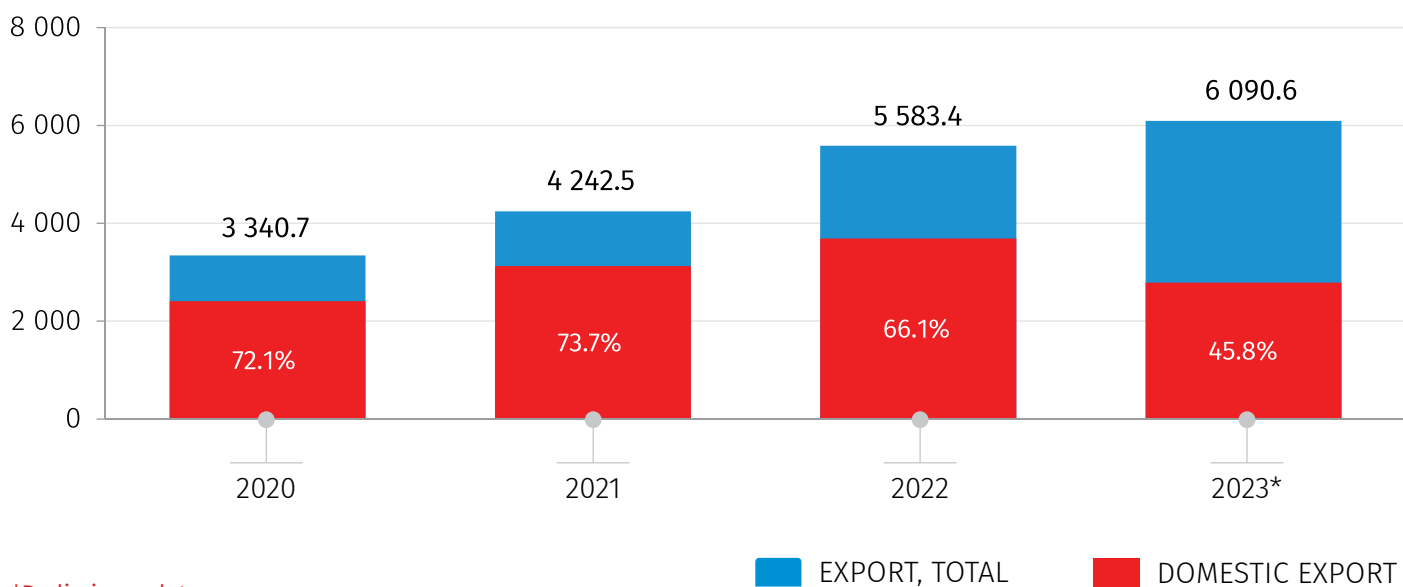

In 2023 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 73.1 percent. The top partners were Russia (USD 541.7 million), Türkiye (USD 343.8 million) and China (USD 270.0 million).

In 2023 copper ores and concentrates claimed the first place in the list of top export items, equaling USD 474.2 million, or 17.0 percent of total exports. The exports of wine of fresh grapes totaled USD 257.7 million and their share in the total exports amounted to 9.2 percent. The exports of ferro-alloys occupied the third place, standing at USD 180.7 million and constituting 6.5 percent of the total exports.
