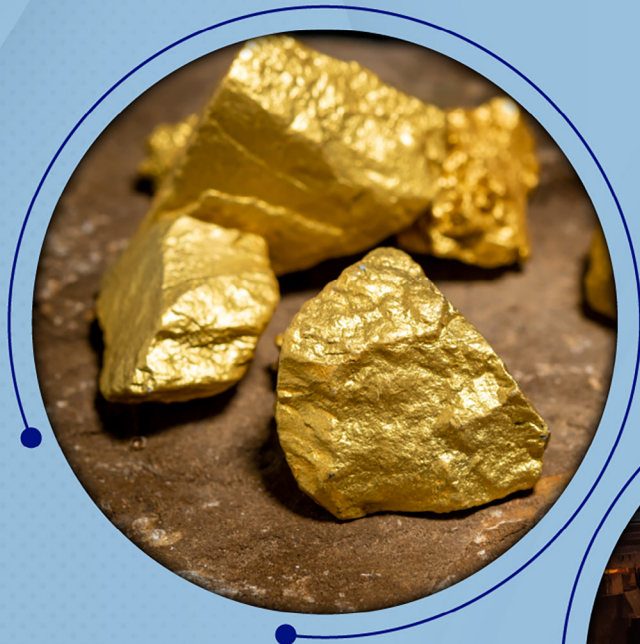

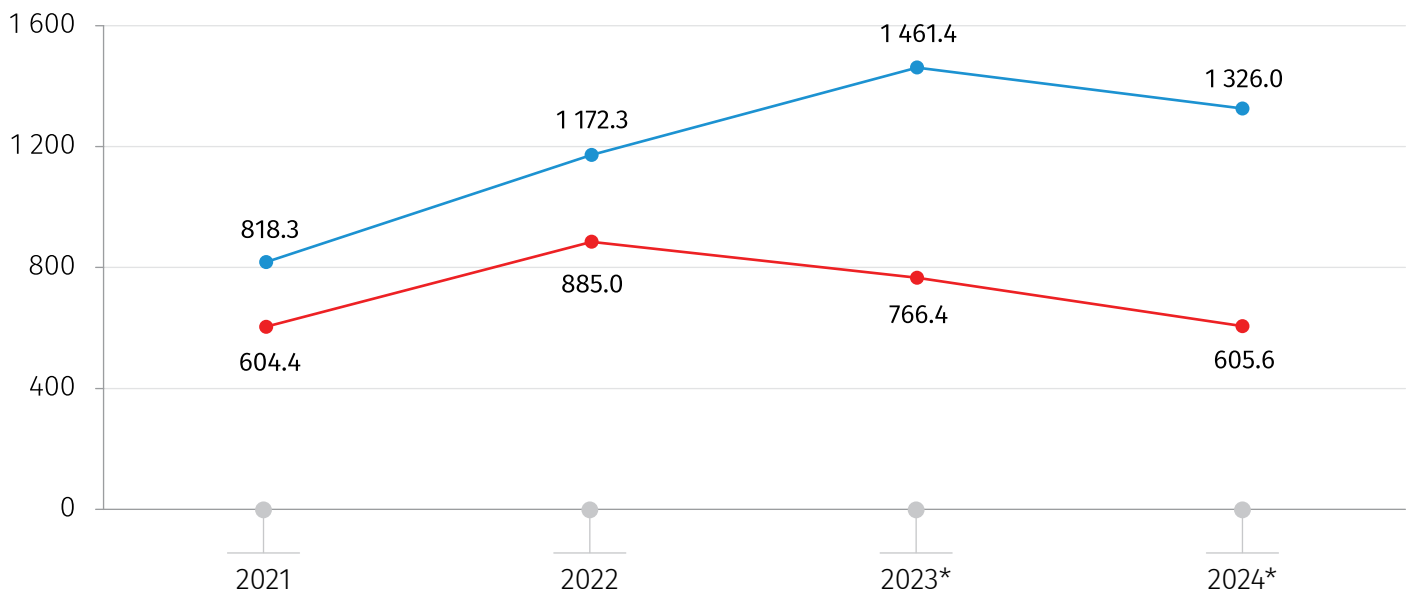

THE DOMESTIC EXPORTS IN JANUARY-MARCH 2024 (PRELIMINARY)

In January-March 2024 the exports of Georgia (excluding non-declared exports) equaled USD 1 326.0 million, 9.3 percent lower year-on-year. Share of the domestic exports in total exports constituted 45.7 percent and amounted to USD 605.6 million, 21.0 percent lower to the same period of 2023.

TREND OF THE EXPORTS IN GEORGIA IN JANUARY-MARCH 2021-2024 (MILL. USD)



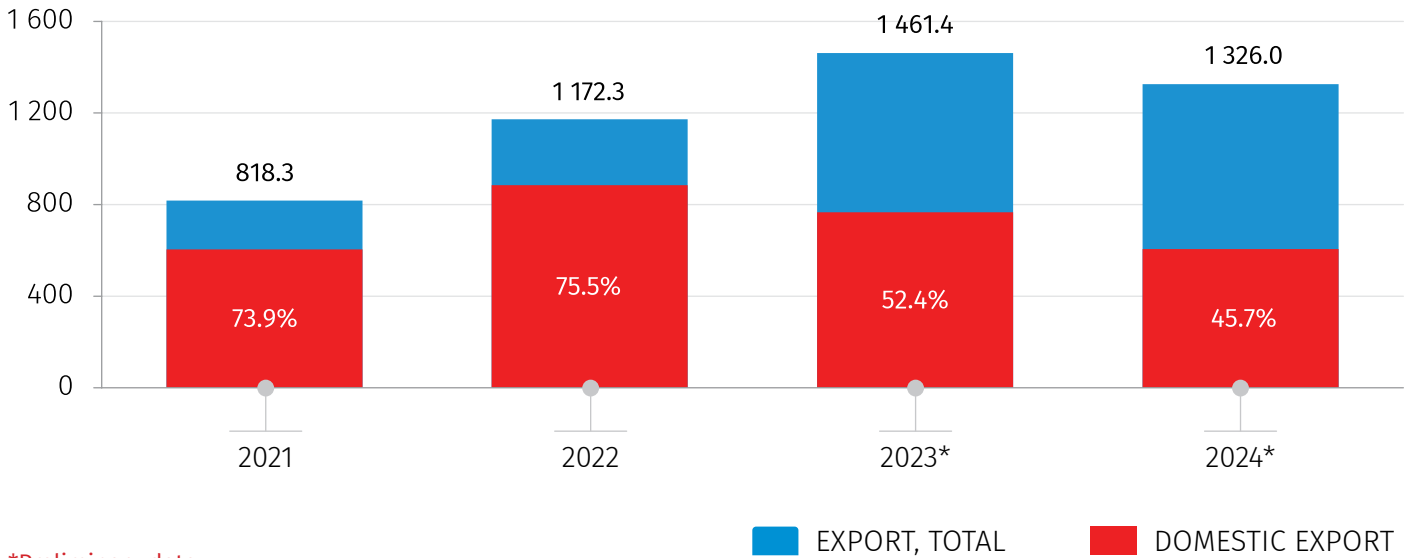

In January-March 2024 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 71.8 percent. The top partners were Russia (USD 132.1 million), Türkiye (USD 82.3 million) and China (USD 56.5 million).

In January-March 2024 wine of fresh grapes reclaimed the first place in the list of top export items, equaling USD 83.2 million, or 13.7 percent of total exports. The exports of ferro-alloys totaled USD 72.5 million and their share in the total exports amounted to 12.0 percent. The exports of precious metal ores and concentrates occupied the third place, standing at USD 39.5 million and constituting 6.5 percent of the total exports.

 4. According to the international methodology, there are some differences in coverage of trade flows between external merchandise trade statistics and customs statistics. Diplomatic, temporary, transit and analogous goods are excluded from the database of external merchandise trade statistics.

The preliminary data will be revised according to the Geostat's revision policy (based on the regular revision principle) as a result of adjusting data by respondents/administrative sources.

Domestic exports include export of goods produced in the country, as well as imported from abroad, the value of which has significantly changed as a result of domestic processing.
