#### 3. Statistical presentation

#### 3.1. Data description

The following basic indicators are published according to the statistical survey of cold storage facilities (quarterly):

- 1. Number of employees in livestock and poultry slaughterhouses;
- 2. Number and weight of livestock/poultry slaughtered in livestock and poultry slaughterhouses;
- 3. Number of consumers of livestock and poultry slaughterhouses' services;
- 4. Average price of slaughtering unit livestock/poultry in livestock and poultry slaughterhouses;
- 5. Volume (slaughtered weight) of meat produced in livestock and poultry slaughterhouses;
- 6. Meat purchased for resell by livestock and poultry slaughterhouses.

# 3.2. Classification system

The National Classification of Economic Activities (NACE Rev.2).

#### 3.3. Sector coverage

The survey is carried out according to the list provided by the Ministry of Environmental Protection and Agriculture of Georgia (MEPA).

# 3.4. Statistical concepts and definitions

Active Enterprise - All active enterprises included in the list provided by the MEPA.

**Number of Employees** – Average number of people employeed (hired persons, employed owner, and employed members of family in case of family-owned enterprise) in livestock and poultry slaughterhouses in the reporting period.

**Number of slaughtered livestock/poultry** – Number of livestock and poultry slaughtered in the livestock and poultry slaughterhouses in the reporting quarter.

Produced meat (slaughtered weight) – Weight of produced meat in kilograms.

**Amount of meat purchased by slaughterhouses for resell** – The part of meat out of the total amount of meat produced purchased by slaughterhouse for resell.

**Average price of service** – Average price for slaughtering a unit of livestock/poultry.

**Number of consumers who received service** – Total number of consumers (enterprises, households) that received services provided by livestock and poultry slaughterhouses.

Enterprise.

All active enterprises present in the list provided by the MEPA.

The entire territory of Georgia, except for the occupied regions.

From 2015.

# 7. Confidentiality

# 7.1. Confidentiality - policy

1. The Law of Georgia on Official Statistics:

- According to the article 5 of the law Statistical confidentiality and exclusive use for statistical purposes individual data collected or received by the producer of official statistics, relating to natural or legal persons, must be strictly confidential and used only for statistical purposes.
- According to the article 34 (Observing Confidentiality of Statistical Data) of the law 1. Data collected, processed, and stored to produce official statistics are confidential if they enable the direct or indirect identification of a statistical unit. In addition, aggregated data are subject to statistical confidentiality: a) Aggregates composed of 1 to 3 units, when the unit is a natural or legal person if one of these units could be identified indirectly, thereby disclosing individual data about this unit. Aggregates composed of more than 3 units may be declared confidential by the Executive Director if required to ensure statistical confidentiality; b) Information declares as a state secret on the basis of the "Law of Georgia on State Secrets". 2. Confidential data about the administrative body cannot be considered confidential information, except for the information determined by the Law of Georgia "On State Secrets". 4. Individual data obtained from publicly available sources, which are defined as public information in accordance with the legislation of Georgia, shall not be considered confidential (individual) data may be published if there is written consent from the statistical unit regarding the publication of such data. 6. It is not allowed to disseminate and distribute confidential data or use it for non-statistical purposes.
- According to the article 38 (Confidentiality commitments) of the law the confidential statistical data collected and processed for statistical purposes shall not be used or disseminated either for personal, academic, research or any other activities, by the employees of the producers of Official Statistics. https://www.geostat.ge/media/56202/The-Law-of-Georgia-on-Official-Statistics.pdf

Following types of non-sampling errors might be present in the survey of slaughterhouses: data entry errors, errors in data processing.

The survey results are published on the 47th day after the end of the reporting period.

#### 14.2. Punctuality

The data is published according to the date specified in the statistical work program. There has not been any violation of publication dates.
