

# INFLATION RATE IN GEORGIA, DECEMBER 2024

In December 2024 the Consumer Price Index increased by 0.7 percent compared to the previous month, while the annual inflation rate amounted to 1.9 percent.

With regard to the annual core inflation<sup>1</sup>, the prices increased by 2.3 percent, while the annual core inflation without tobacco<sup>2</sup> also amounted to 2.3 percent.

The following table shows percentage changes in prices for the commodity groups of the consumer basket as well as the relevant contributions to the overall monthly inflation rate.

The monthly inflation rate was mainly influenced by price changes for the following groups:

**Food and non-alcoholic beverages:** the prices for the group increased by 1.3 percent, contributing 0.46 percentage points to the overall monthly inflation rate. The prices increased for the following subgroups: vegetables (5.3 percent), oils and fats (3.0 percent), milk, cheese and eggs (2.4 percent), coffee, tea and cocoa (1.0 percent), meat (0.6 percent), fish (0.5 percent). At the same time, prices decreased for the following subgroups: fruit and grapes (-1.0 percent), mineral waters, soft drinks, fruit and vegetable juices (-0.5 percent);

**Health:** the prices increased by 1.4 percent, contributing 0.14 percentage points to the overall index. The prices were higher for medical products, appliances and equipment (2.2 percent);


**Transport:** the prices for the group increased by 0.5 percent, contributing 0.06 percentage points to the overall index. Within the group the prices increased for transport services (1.2 percent), purchase of vehicles (1.2 percent) and operation of personal transport equipment (0.2 percent);

**Clothing and footwear:** the prices decreased by 1.8 percent, contributing -0.07 percentage points to the overall monthly inflation rate. Prices were lower for both footwear (-3.7 percent) and clothing (-1.1 percent).

The following table shows percentage changes in prices for the commodity groups of the consumer basket, as well as the relevant contributions to the overall annual inflation rate in December 2024.

The annual inflation rate was mainly influenced by price changes for the following groups:

Food and non-alcoholic beverages: the prices in the group increased by 3.6 percent, contributing 1.18 percentage points to the overall annual inflation rate. Within the group the prices increased for the following subgroups: vegetables (15.7 percent), oils and fats (10.1 percent), coffee, tea and cocoa (8.8 percent), sugar, jam, honey, chocolate and confectionery (6.9 percent), mineral waters, soft drinks, fruit and vegetable juices (5.5 percent), fish (4.8 percent), meat (1.3 percent), bread and cereals (0.3 percent). At the same time, the prices decreased for fruit and grapes (-0.7 percent), milk, cheese and eggs (-0.6 percent);

**Alcoholic beverages and tobacco:** the prices increased by 5.9 percent, with the relevant contribution of 0.4 percentage points to the overall annual inflation rate. The prices increased for both alcoholic beverages (9.2 percent) and tobacco (2.0 percent);

**Health:** the prices increased by 3.7 percent, contributing 0.35 percentage points to the overall index. The prices were higher for the following subgroups: medical products, appliances and


equipment (4.5 percent), out-patient services (3.8 percent), hospital services (1.0 percent);

**Miscellaneous goods and services:** the prices for the group increased by 6.4 percent, contributing 0.33 percentage points to the overall index. Within the group, the prices were higher mainly for the following subgroups: personal effects n.e.c. (23.3 percent), insurance (12.9 percent), financial services n.e.c. (4.5 percent), personal care (3.1 percent);

**Communication:** the prices decreased by 12.7 percent, contributing -0.47 percentage points to the overall index;

Housing, water, electricity, gas and other fuels: the prices for the group decreased by 3.2 percent, contributing -0.27 percentage points to the overall index. The prices were lower for the subgroups of electricity, gas and other fuels (-5.3 percent) and actual rentals for housing (-0.7 percent). At the same time, the prices increased for maintenance and repair of the dwelling (5.7 percent).



(12 MONTH AVERAGE OVER THE PREVIOUS 12 MONTH AVERAGE, PERCENTAGE CHANGE)



(%)




