THE DOMESTIC EXPORTS IN 2024 (PRELIMINARY)

In 2024 the exports of Georgia (excluding non-declared exports) equaled USD 6 560.4 million, 7.8 percent higher year-on-year. Share of the domestic exports in total exports constituted 45.8 percent and amounted to USD 3 007.1 million, 5.0 percent higher to the same period of 2023.

Geostat also revised the domestic export figures starting from 2019, prompted by the reclassification of specific commodity flows from re-exports to domestic exports. As a result, the table below outlines the updated figures and corresponding changes:

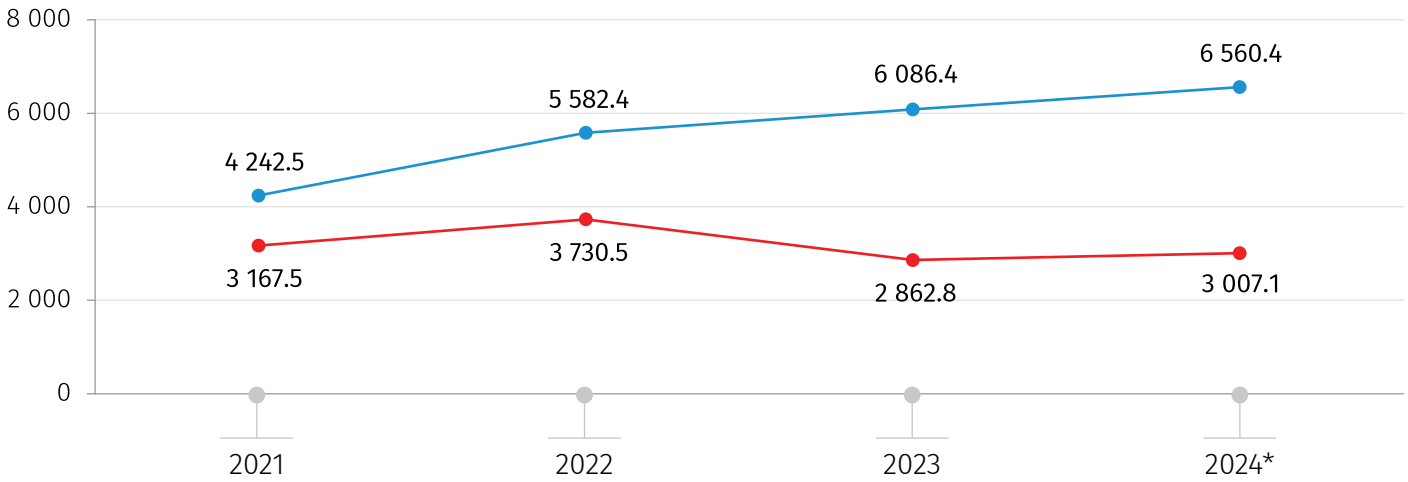

TREND OF THE EXPORTS IN GEORGIA IN 2021-2024 (MILL. USD)

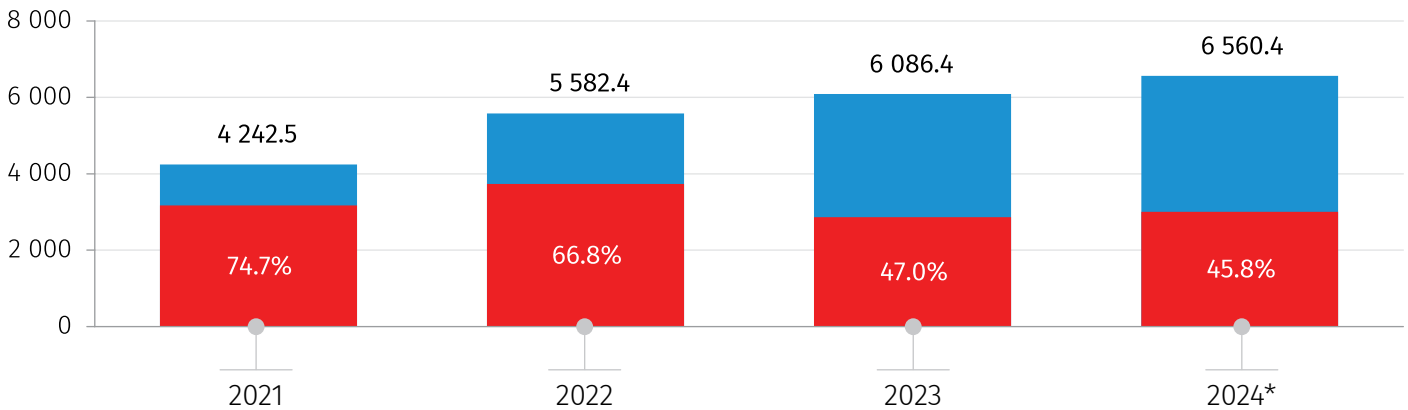

In 2024 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 72.9 percent. The top partners were Russia (USD 653.4 million), Türkiye (USD 402.5 million) and China (USD 273.4 million).

In 2024 ferro-alloys reclaimed the first place in the list of top export items, equaling USD 321.9 million, or 10.7 percent of total exports. The exports of wine of fresh grapes totaled USD 274.7 million and their share in the total exports amounted to 9.1 percent. The exports of spirituous beverages, occupied the third place, standing at USD 250.2 million and constituting 8.3 percent of the total exports.
