## 3. Statistical presentation

## 3.1. Data description

The purpose of Households Incomes and Expenditures Survey is to produce data on income, expenditure, consumption and the living conditions of the population and to obtain data on the annual changes of these indicators.

### 3.2. Classification system

- Classification of Individual Consumption According to Purpose (COICOP);
- Statistical classification of economic activities (NACE Rev. 2) 006-2016.

### 3.3. Sector coverage

Includes all private households of the country. Sample unit is randomly selected household despite the number of household members and their economic conditions.

## 3.4. Statistical concepts and definitions

**Household** is a group of persons who observe the rules of common living and occupy a single dwelling and are connected by the shared budget (or a part thereof), and by relative or non-relative relationships (a household may consist of one person).

**Standard of Living** implies providing the population with material, spiritual, social and living conditions, which is the same as the achieved level of consumption and the degree of satisfaction of human needs.

**Household Incomes** include all incomes of the household and its members during the reference period. Total income (cash and non-cash inflows) consists of cash income and transfers, non-cash income and other cash inflows. Cash income and transfers includes income from wages, self-employment, selling agricultural production, leasing, deposit (interest), pensions, scholarships, assistances, remittances from abroad and money received as gift. Other cash inflows include income from property disposal, borrowing and dissaving.

- Income from wages Wage or other remuneration in cash or in kind, bonuses, gifts, one-time assistances;
- **Income from self-employment** Pure income (self-employment is proprietor's activity income from which depends on final results of the work, on profit);
- Income from selling agricultural production Selling agricultural production produced on the own land.
- **Property income (leasing, interest on deposit, etc.**) Share dividends, interests on bonds or deposits, rent on property leasing;
- Pensions, scholarships, assistances Retirement, disability, loss of bread-winner, disabled veterans, participants in a war, persons equal to them and other special pensions, scholarship, temporary disability benefits (due to illness, childbirth), income from insurance, assistance for socially vulnerable families, single pensioners and disabled persons, IDP-s, aliment, grant;
- Remittances from abroad Money received from abroad or value of goods received as gift from abroad;

- Money received as gift Money received from members of the other households as a gift or assistance;
- **Property disposal** Money received from selling apartment, house, summer cottage, other buildings, household appliances, furniture, clothes, land, etc.;
- **Borrowing or dissaving** Borrowing from other household or institution or using savings with the aim of incurring consumption expenditure;
- **Non-cash income** Goods produced for self-consumption, received free of charge from relatives or via humanitarian assistance, calculated with average prices for the reference period.

**Household Expenditures** include all expenditures of the household and its members during the reference period. Total expenditures consist of cash consumption expenditures, non-cash expenditures, and cash non-consumption expenditures. Cash consumption expenditures includes expenditures on food, beverages, tobacco, clothes and footwear, household goods, healthcare, housing, water, electricity, gas and other fuels, transport, education and other consumption expenditures. Cash non-consumption expenditures includes expenditures on agriculture, transfers, saving and lending, property acquirement.

- Expenditures on food, beverages, tobacco Includes expenditures on food products (bread and bread products, meat products, fish, milk and dairy products, fruits, vegetables, meats, pastries, etc.), on non-alcoholic beverages, alcoholic beverages and tobacco products;
- Expenditures on clothes and footwear Includes expenditures on women's, men's and children's clothing and footwear, including their repair, sewing, dry cleaning, dyeing and sourcing. Also includes the cost of humanitarian aid or clothing and footwear received free of charge (donated) from relatives;
- Expenditures on household goods Includes expenditures on furniture, textiles, utensils, household appliances and equipment, work tools, cleanliness items, housekeeping, home care, etc. Additionally, it covers the cost of humanitarian aid or items received free of charge (gifted);
- Expenditures on healthcare Includes expenditures on pharmaceuticals, therapeutic equipment and devices, medical services, dentistry, surgical services, childbirth, etc. Also includes the cost of humanitarian aid or services received free of charge from relatives;
- Expenditures on housing, water, electricity, gas and other fuels Includes rent for the primary rented accommodation, expenditures on maintenance and repair services for housing, water supply, electricity and natural gas bills, purchase and repair of meters for these utilities, liquefied gas and solid fuel, central heating, etc. Also includes the cost of humanitarian aid or services received free of charge from relatives;
- Expenditures on transport Includes expenditures on cars, motorcycles, bicycles, animal transport, spare parts and equipment, fuel, lubricants, maintenance, passenger transport by railway, road, air, sea, etc. Also includes the cost of services received free of charge by relatives;
- Expenditures on education Includes expenditures on preschool, elementary, secondary and higher education, training and qualification courses, etc. It also includes the cost of services received free of charge by relatives;
- Expenditures on agriculture Includes expenditures on land taxes and rents, fertilizer-poisoning, seed, equipment hire, land cultivation, veterinary services, livestock and poultry feed, etc. It also includes the value of goods and services received free of charge by relatives;
- Expenditures on transfers Includes expenditures on gifts, money donated, inherited or cost of gifted flat, cottage, car, gems, furniture, etc.;
- Expenditures on saving and lending Includes money borrowed, savings made by the household, amount deposited in the bank account, debt repaid, hidden credit, hidden fees and unearned income for a specified period;
- Expenditures on property acquirement Includes expenditures on purchasing relatively expensive goods (bonds, capital, land, antiquarian and unique materials, gems, flat, cottage, etc.), wall materials, steel materials, roofing materials, doors and windows, electric system, mini-bus or lorry, tractor, mini-tractor or motor-block, joiner's or metal working tools, productive or breeding domestic animals and poultry, etc.;
- Non-cash expenditures Value of self-produced goods, products received free of charge from the relatives or via humanitarian assistance, calculated based on the average prices of the reference period.

## 7. Confidentiality

## 7.1. Confidentiality – policy

- 1. The Law of Georgia on Official Statistics:
  - According to the article 5 of the law Statistical confidentiality and exclusive use for statistical purposes individual data collected or received by the producer of official statistics, relating to natural or legal persons, must be strictly confidential and used only for statistical purposes.
  - According to the article 34 (Observing Confidentiality of Statistical Data) of the law 1. Data collected, processed, and stored to produce official statistics are confidential if they enable the direct or indirect identification of a statistical unit. In addition, aggregated data are subject to statistical confidentiality: a) Aggregates composed of 1 to 3 units, when the unit is a natural or legal person if one of these units could be identified indirectly, thereby disclosing individual data about this unit. Aggregates composed of more than 3 units may be declared confidential by the Executive Director if required to ensure statistical confidentiality; b) Information declares as a state secret on the basis of the "Law of Georgia on State Secrets". 2. Confidential data shall be used exclusively for the purposes of producing statistics in accordance with this law. 3. Statistical data about the administrative body cannot be considered confidential information, except for the information determined by the Law of Georgia "On State Secrets". 4. Individual data obtained from publicly available sources, which are defined as public information in accordance with the legislation of Georgia, shall not be considered confidential information. 5. Confidential (individual) data may be published if there is written consent from the statistical unit regarding the publication of such data. 6. It is not allowed to disseminate and distribute confidential data or use it for non-statistical purposes.
  - According to the article 38 (Confidentiality commitments) of the law the confidential statistical data collected and processed for statistical purposes shall not be used or disseminated either for personal, academic, research or any other activities, by the employees of the producers of Official Statistics.

### 13. Accuracy and reliability

## 13.1. Overall accuracy

Households Incomes and Expenditures Survey is based on a sampling method. In General, it is attended by existence of statistical errors. Therefore, during the calculation of survey results standard error is taken into consideration.

## 13.2. Sampling error

In 2024, sample size comprised 17 280 households. 13 105 households were interviewed countrywide. Response rate of households which is calculated as interviewed households divided on sampled households, amounted to 75.8 percent. The table below represents standard errors, confidence intervals, coefficients of variation and design effects of indicators:

# 13.3. Non-sampling error

Non-sampling error can occur because of sampling frame inaccuracy. The sampling frame of Households Incomes and Expenditures Survey is based on the database of General Population Census of 2014. Updating the sampling frame takes

long time. Non-sampling error can also be caused by non-responses – refusal of respondents on obtaining information or incomplete information. Non-sampling errors can also occur for other reasons too.

## 16. Cost and burden

- There are 130-140 interviewers involved in the survey in 11 regional offices;
- Logical control group 4 members and data entry operators 3 members;
- Database is cleaned by 6 permanent staff members of division;
- The monthly sample size is 4 320/3 = 1 440 households, with 4 320 households per quarter;
- Average duration of initial and follow-up interviews 1 hour –1 h 20 min;
- In addition, each household completes Diary of expenses, which includes household members' expenditure on food and non-food products during the past week. The time spent on filling the diary depends on the specific case and cannot be estimated.

In 2024, budget of Households Incomes and Expenditures Survey amounted to 519.8 thousand GEL.

## 18. Statistical processing

## 18.1. Source data

The main source of the data on household income and expenditure is Households Incomes and Expenditures Survey (Integrated Household Survey - Before 2017).

The sampling frame is based on the General Population Census 2014 (Before 2017 the sampling frame was based on the General Population Census 2002). New listing of households (actualization) is conducted in all sampled enumeration areas. Pre-defined number of households are selected from the sampling frame on a random sampling basis. Sampling is done using a specially designed program.

Two-stage stratified cluster random sampling is used for sampling design. At the first stage, enumeration areas are selected, and at the second stage – household addresses. In addition, stratification is done to reduce sampling errors. From 2017 each household is interviewed based on the 2-2-2 rotation scheme. This implies that the interviews are conducted twice during the two quarters and the third and fourth interviews are conducted in the same quarters of the next year when the first and second interviews were conducted. Before 2017 each household was interviewed four times in a row for four quarters.

Each month the households which were participating in the sample for four times are excluded from the sample and

they are replaced by another randomly selected household from the same cluster (household rotation). This rotation scheme allows to renew the sample on the one hand, and on the other hand, to create panel survey which is necessary for the poverty study.

## 18.2. Frequency of data collection

Data is collected monthly.

#### 18.3. Data collection

To collect data, interviewer goes to the respondent's household and completes five questionnaires (by the Computer-Assisted Personal Interview – CAPI). Sixth Questionnaire – Expenditure Diary (printed version) is designed to leave in the household. It includes household members' expenditure on food and non-food products during the past week. The expenditure diary is filled by the household within one week according to the instructions given by the interviewer. For this purpose, interviewer conducts 3 visits in the household. Interviewer fills-in the non-response form for the primary sampling unit level with reasons for refusal.

### 18.4. Data validation

Initially, data received from the respondent has been validated during the interview using a tablet, which includes integrated basic logical and arithmetic checks in the online questionnaires. If any discrepancies are detected in the data provided by the respondent, the interviewer will clarify the answers on the spot. The completed online questionnaires are sent by the interviewers to the fieldwork supervisors using a special program, who then forward them to the logical control group. If suspicious data or discrepancies are detected, the questionnaire is returned to the interviewer for clarification/verification. The clarified questionnaire is then sent to the head office.

Each month, double data entry is conducted by the operators' team to input the expenditures diary data (printed version) into the database within 10-15 days after receiving the material (15th-20th days after the end of the survey month). The purpose of double data entry is to prevent data entry errors. If there is any discrepancy between the first and second inputs, the specially designed program indicates the difference. The operator has to determine which record is correct and corrects the data.

After recording the materials into the database, a specially designed program identifies and shows inconsistencies in the data. In case of inconsistency, logical control group corrects data based on contacting interviewer/supervisor and/or respondent and the information received from them.

Finally, data cleaning is continued using Microsoft Access by the staff of the Living Conditions Statistics Division. Data comparison between questionnaires and quarters is implemented as well.

# 18.5. Data compilation

After the cleaning of the database, the aggregated database is formed and the data is weighted. The data is weighted at the stratum-panel level. Results are calculated using MS Access, MS Excel and SPSS.
