Number of employees in livestock and poultry slaughterhouses; 2. Number and weight of livestock/poultry slaughtered in livestock and poultry slaughterhouses; 3. Number of consumers of livestock and poultry slaughterhouses' services; 4. Maximum daily capacity of slaughtered livestock/poultry in livestock and poultry slaughterhouses; 5. Average price of slaughtering unit livestock/poultry in livestock and poultry slaughterhouses; 6. Volume (slaughtered weight) of meat produced in livestock and poultry slaughterhouses; 7. Meat purchased for resell by livestock and poultry slaughterhouses.

<p>Active Enterprise – All active enterprises included in the list provided by the MEPA.</p> <p>Number of Employees – Average number of people employed (hired persons, employed owner, and employed members of family in case of family-owned enterprise) in livestock and poultry slaughterhouses in the reporting period.</p> <p>Number of slaughtered livestock/poultry – Number of livestock and poultry slaughtered in the livestock and poultry slaughterhouses in the reporting year.</p> <p>Produced meat (slaughtered weight) – Weight of produced meat in kilograms.</p> <p>Amount of meat purchased by slaughterhouses for resell – The part of meat out of the total amount of meat produced purchased by slaughterhouse for resell.</p> <p>Average price of service – Average price for slaughtering a unit of livestock/poultry.</p> <p>Number of consumers who received service – Total number of consumers (enterprises, households) that received services provided by livestock and poultry slaughterhouses.</p>

7. Confidentiality
7.1. Confidentiality – policy
<p>1. The Law of Georgia on Official Statistics:</p> <ul style="list-style-type: none"> • According to the article 5 of the law Statistical confidentiality and exclusive use for statistical purposes – individual data collected or received by the producer of official statistics, relating to natural or legal persons, must be strictly confidential and used only for statistical purposes. • According to the article 34 (Observing Confidentiality of Statistical Data) of the law 1. Data collected, processed, and stored to produce official statistics are confidential if they enable the direct or indirect identification of a statistical unit. In addition, aggregated data are subject to statistical confidentiality: a) Aggregates composed of 1 to 3 units, when the unit is a natural or legal person if one of these units could be identified indirectly, thereby disclosing individual data about this unit. Aggregates composed of more than 3 units may be declared confidential by the Executive Director if required to ensure statistical confidentiality; b) Information declares as a state secret on the basis of the „Law of Georgia on State Secrets“. 2. Confidential data shall be used exclusively for the purposes of producing statistics in accordance with this law. 3. Statistical data about the administrative body cannot be considered confidential information, except for the information determined by the Law of Georgia „On State Secrets“. 4. Individual data obtained from publicly available sources, which are defined as public information in accordance with the legislation of Georgia, shall not be considered confidential information. 5. Confidential (individual) data may be published if there is written consent from the statistical unit regarding the publication of such data. 6. It is not allowed to disseminate and distribute confidential data or use it for non-statistical purposes. • According to the article 38 (Confidentiality commitments) of the law the confidential statistical data collected and processed for statistical purposes shall not be used or disseminated either for personal, academic, research or any other activities, by the employees of the producers of Official Statistics. https://www.geostat.ge/media/56202/The-Law-of-Georgia-on-Official-Statistics.pdf <p>2. 11. Quality management
11.1. Quality assurance
To ensure the quality of the statistical processes and products Geostat follows Chapter 10 – Quality of official statistics – of the Law of Georgia on Official Statistics, as well as the European Statistics Code of Practice, the UN Fundamental Principles of Official Statistics and Quality Assurance Framework of the European Statistical System (ESS QAF).
11.2. Quality assessment
Methodology and Quality Management Division of Geostat, along with the sectoral departments, is responsible for the quality of the produced statistical products and processes. The Division carries out quality audit, self-assessment of statistical processes and assesses the risks for the quality of statistical processes and products. Geostat has developed policy documents, guidelines and standard routine descriptions. These documents ensure the standardization of statistical processes and products and the establishment of a unified quality assurance system. 12.1. User needs
The main stakeholders are: business sector representatives, researchers and students, international organizations, state institutions, media outlets, etc. They need these data to carry out different types of statistical analysis, to plan a marketing strategy or to evaluate and study the economic environment.

13.1. Overall accuracy
The processed data is compared to the relevant data of the last period. In some cases, data is verified using administrative data sources, or with the representatives of the enterprises.
13.2. Sampling error
The survey is conducted with total enumeration.
13.3. Non-sampling error
Following types of non-sampling errors might be present in the survey of slaughterhouses: data entry errors, errors in data processing.
14. Timeliness and punctuality
14.1. Timeliness
The survey results are published on June 15 of the next year of the reporting period.
14.2. Punctuality
The data is published according to the date specified in the statistical work program. There has not been any violation of publication dates.
15. Coherence and comparability
15.1. Comparability – geographical
Methodology and approaches are identical for Georgian regions.
15.2. Comparability – over time
The data is comparable over time.
15.3. Coherence – cross domain
The data is coherent.
15.4. Coherence – internal
The data is coherent.
