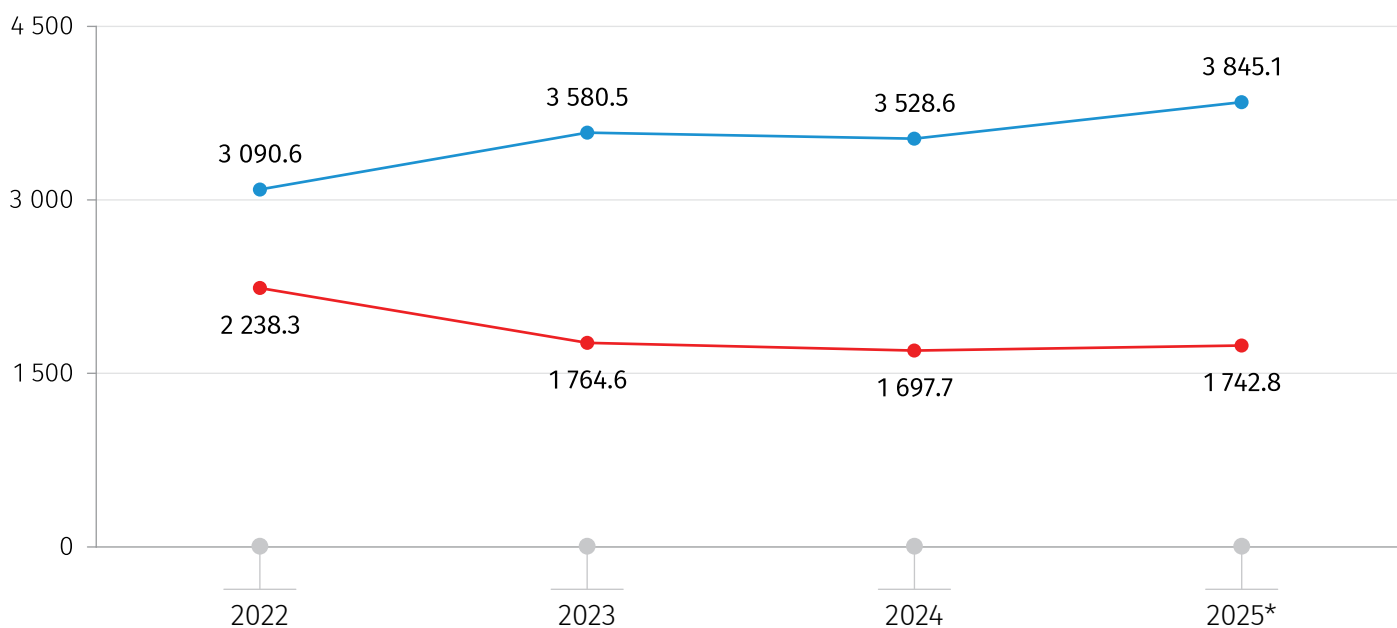

THE DOMESTIC EXPORTS IN JANUARY-JULY 2025 (PRELIMINARY)

In January-July 2025 the exports of Georgia (excluding non-declared exports) equaled USD 3 845.1 million, 9.0 percent higher year-on-year. Share of the domestic exports in total exports constituted 45.3 percent and amounted to USD 1 742.8 million, 2.7 percent higher to the same period of 2024.

● EXPORT, TOTAL

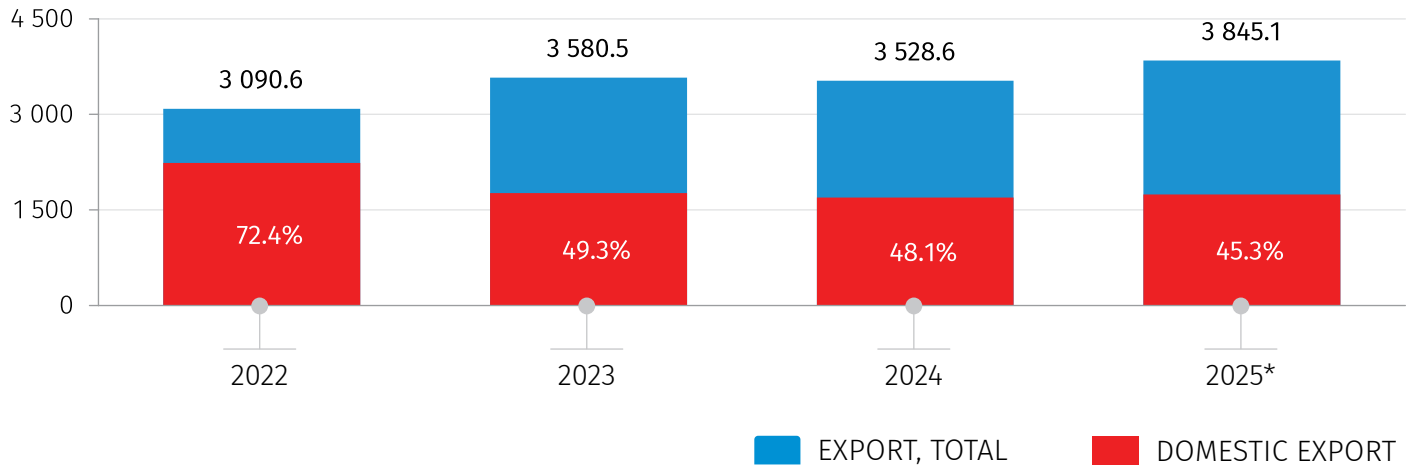

In January-July 2025 the share of the top ten trading partners by domestic exports in the total domestic exports of Georgia amounted to 70.8 percent. The top partners were Russia (USD 385.6 million), Türkiye (USD 175.2 million) and China (USD 168.8 million).

In January-July 2025 precious metal ores and concentrates claimed the first place in the list of top domestic export items, equaling USD 202.9 million, or 11.6 percent of total domestic exports. The domestic exports wine of fresh grapes totaled USD 144.8 million and their share in the total domestic exports amounted to 8.3 percent. The domestic exports of spirituous beverages occupied the third place, standing at USD 122.3 million and constituting 7.0 percent of the total domestic exports.

 4. According to the international methodology, there are some differences in coverage of trade flows between external merchandise trade statistics and customs statistics. Diplomatic, temporary, transit and analogous goods are excluded from the database of external merchandise trade statistics.

Domestic exports include export of goods produced in the country, as well as imported from abroad, the value of which has significantly changed as a result of domestic processing.
