PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS IN GEORGIA

JULY 2025

In July 2025, the Producer Price Index for Industrial Products increased by 0.02 percent compared to the previous month, while compared to July 2024, the index increase amounted to 3.6 percent.

The prices for mining and quarrying decreased by 1.2 percent compared to June 2025, resulting in a -0.08 percentage point contribution to the overall monthly PPI change. In the same period, the prices for manufactured products decreased by 0.3 percent, contributing -0.21 percentage points to the monthly index change. Within the group, a noteworthy price decrease was registered for food products (-0.7 percent). Besides, the prices increased for electricity, gas, steam and air **conditioning** by 3.0 percent, contributing 0.31 percentage points to the monthly index change.

The **annual PPI** rate was mainly affected by price changes for the following products:

- Mining and quarrying: the prices were 13.9 percent higher, contributing 0.87 percentage points to the overall annual index change. Within the group, the prices were higher for the subgroup of metal ores (19.3 percent);
- Manufactured products: the prices increased by 2.0 percent, contributing 1.66 percentage points to the overall annual index increase. There was a notable increase in the prices for food products (3.9 percent) and beverages (4.5 percent);
- Electricity, gas, steam and air conditioning: the annual price increase amounted to 10.0 percent, which contributed 1.03 percentage points to the annual index change;




PRODUCER PRICE INDEX FOR INDUSTRIAL PRODUCTS

(THE SAME MONTH OF THE PREVIOUS YEAR =100)


