
PRODUCER PRICE INDICES FOR SERVICES IN GEORGIA

AUGUST 2025

KEY POINTS:

- Producer Price Index for Transportation and Storage Services increased by 0.1 percent compared to the previous month and decreased by 0.6 percent compared to August 2024;
- **Producer Price Index for Telecommunication Services** increased by 0.1 percent compared to the previous month, while the overall annual index went down by 0.6 percent;
- **Producer Price Index for Accommodation and Food Services** increased by 1.6 percent compared to the previous month, while the overall annual index went up by 7.8 percent.

PRODUCER PRICE INDEX FOR TRANSPORTATION AND STORAGE SERVICES

Producer Price Index for Transportation and Storage Services increased by 0.1 percent compared to the previous month. In the mentioned period the prices increased by 1.7 percent for air transport services and decreased by 17.4 percent for water transport services. Along with this, the prices decreased for warehousing and support services for transportation by 0.2 percent and by 0.1 percent for land transport services and transport services via pipelines.

Compared to August 2024 the overall index decreased by 0.6 percent. In the mentioned period the prices for water transport services decreased by 5.0 percent, while for air transport services went down by 4.8 percent. Along with this, the prices decreased for warehousing and support services for transportation by 4.9 percent and increased by 0.9 percent for land transport services and transport services via pipelines.

The following table presents the Producer Price Index for Transportation and Storage Services in August 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.

PRODUCER PRICE INDEX FOR TELECOMMUNICATION SERVICES

The total Producer Price Index for Telecommunication Services increased by 0.1 percent compared to the previous month. In the mentioned period the prices increased for wired telecommunications services by 2.2 percent. Moreover, other telecommunications services decreased by 6.6 percent, while the prices for wireless telecommunications services remain unchanged.

The overall index went down by 0.6 percent **compared to the same month of the previous year**. In the mentioned period the prices for other telecommunications services decreased by 11.5 percent. Along with this, the prices for wired telecommunications services increased by 2.2 percent, while the prices for wireless telecommunications services remain unchanged.

The following table presents the Producer Price Index for Telecommunication Services in August 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.

PRODUCER PRICE INDEX FOR ACCOMMODATION AND FOOD SERVICES

Producer Price Index for Accommodation and Food Services went up by 1.6 percent **compared to the previous month**. The prices increased for accommodation services by 3.4 percent, while the prices for food and beverage serving services increased by 0.1 percent.

The overall index posted a 7.8 percent increase **compared to August 2024**. In the mentioned period the prices increased by 9.6 percent for accommodation services, while the prices for food and beverage serving services increased by 6.8 percent.

The following table presents the Producer Price Index for Accommodation and Food Services in August 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.
