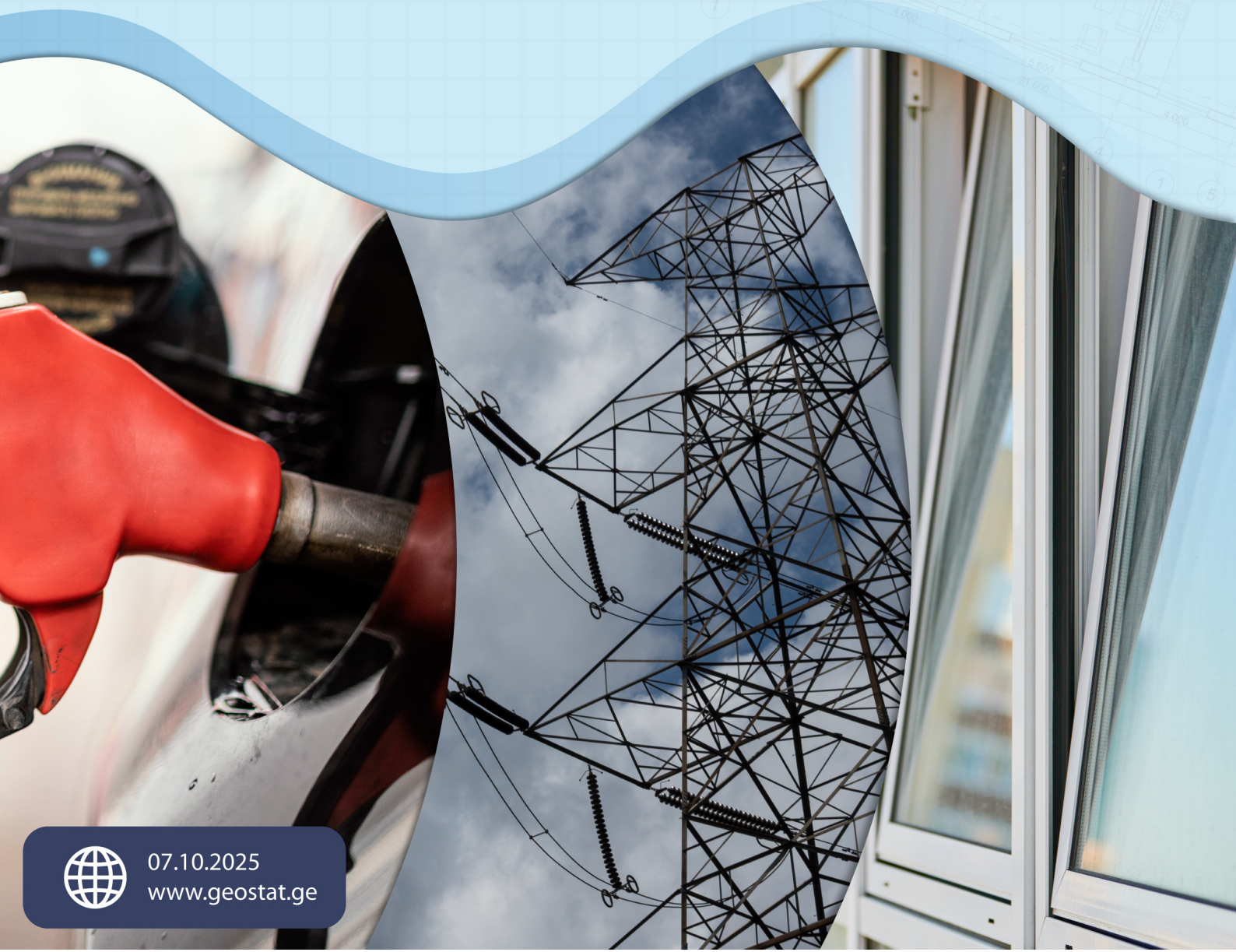

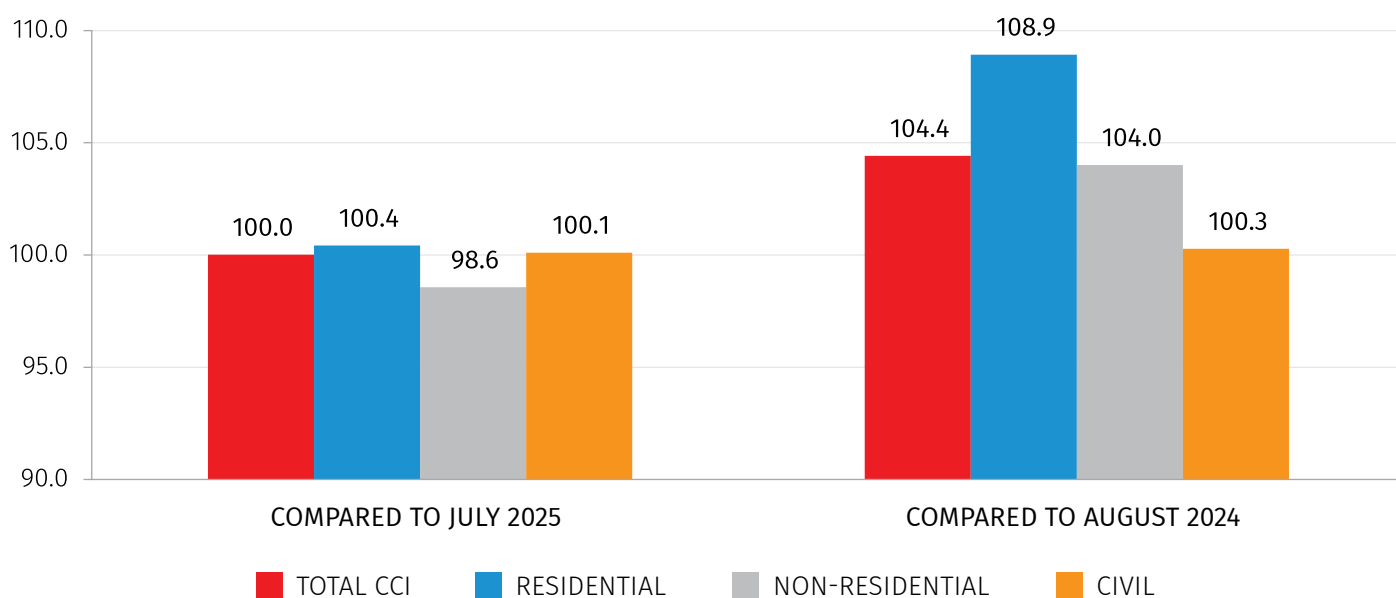
CONSTRUCTION COST INDEX IN GEORGIA AUGUST 2025

In August 2025 the Construction Cost Index (CCI) increased by 0.02 percent **compared to the previous month**, while it increased by 4.4 percent compared to August 2024.

In detail:

- The **residential segment index** increased by 0.4 percent compared to the previous month and increased by 8.9 percent compared to the same month of the previous year;
- The **non-residential segment index** decreased by 1.4 percent compared to the previous month and increased by 4.0 percent compared to the same month of the previous year;
- The **civil segment index** increased by 0.1 percent compared to the previous month and increased by 0.3 percent compared to the same month of the previous year.

In August 2025 the Construction Cost Index (CCI) increased by 0.02 percent **compared to the previous month**. The change was mainly due to a 1.2 percent increase in the transportation, fuel and electricity cost category, which contributed 0.1 percentage points to the total index change.

Compared to August 2024 the CCI increased by 4.4 percent. The latter was largely caused by the 16.1 percent increase in average monthly nominal wages of employees in the construction sector and by the 5.3 percent increase in the cost category of machinery, which contributed 3.87 and 0.34 percentage points to the total index change, respectively. Along with this, the Construction Cost Index posted a 25.0 percent increase **compared to February 2022**.

The following table presents the CCI in August 2025, compared to the previous month and the same month of the previous year, as well as the contributions of cost categories and segments to the total index.

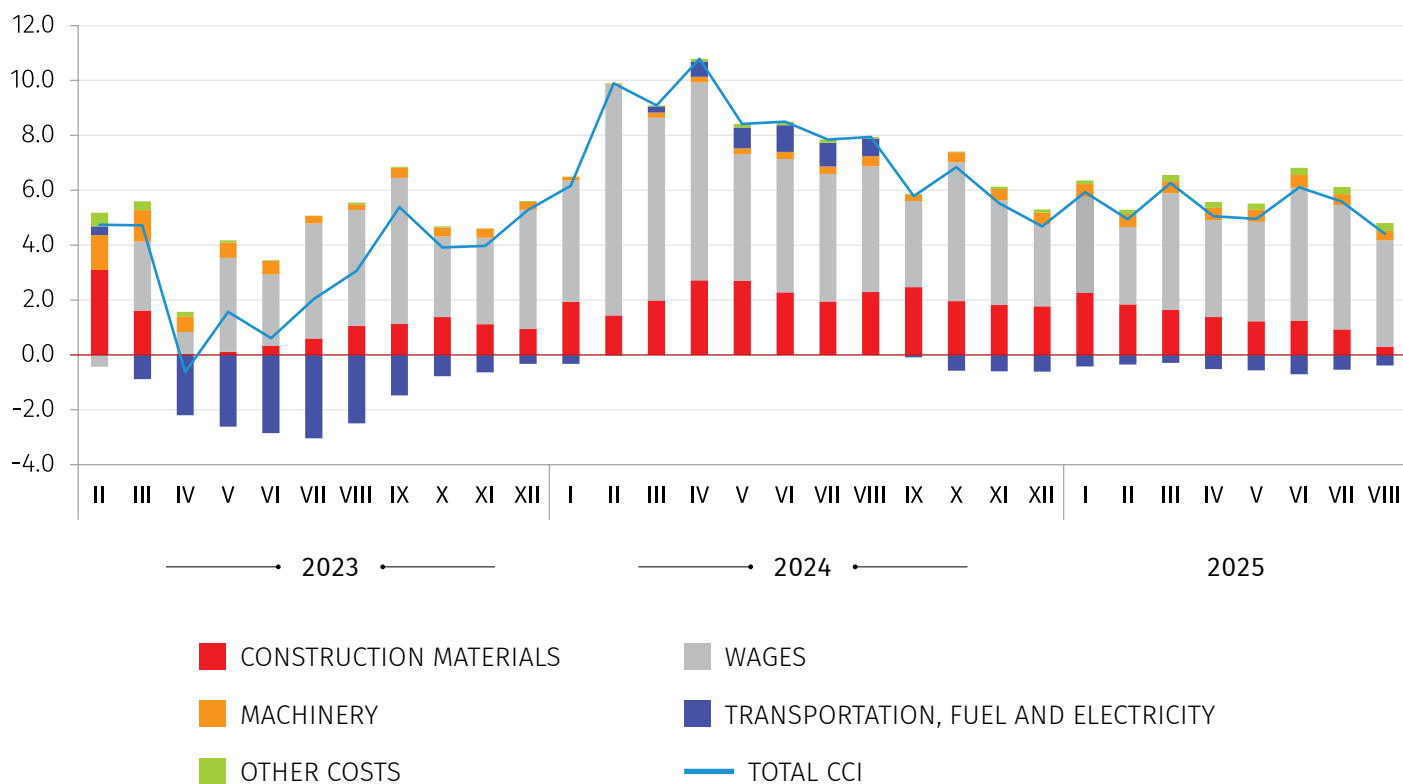

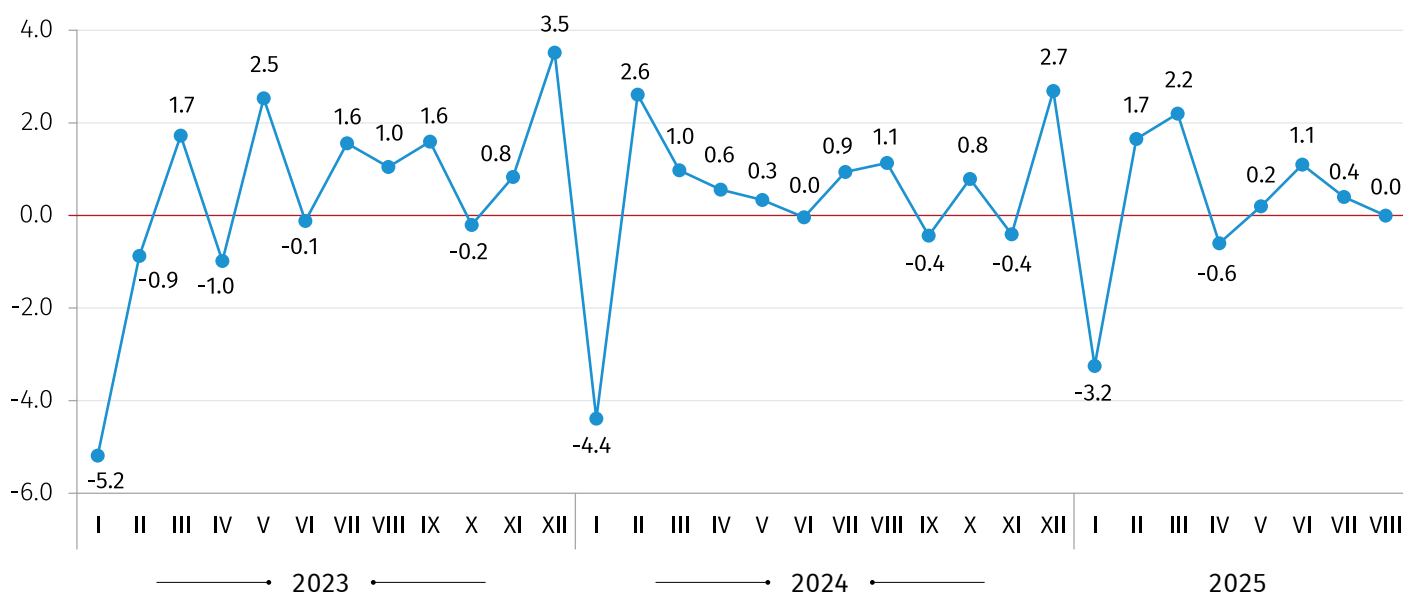

DECOMPOSITION OF THE ANNUAL CHANGE IN THE CONSTRUCTION COST INDEX BY COST CATEGORIES



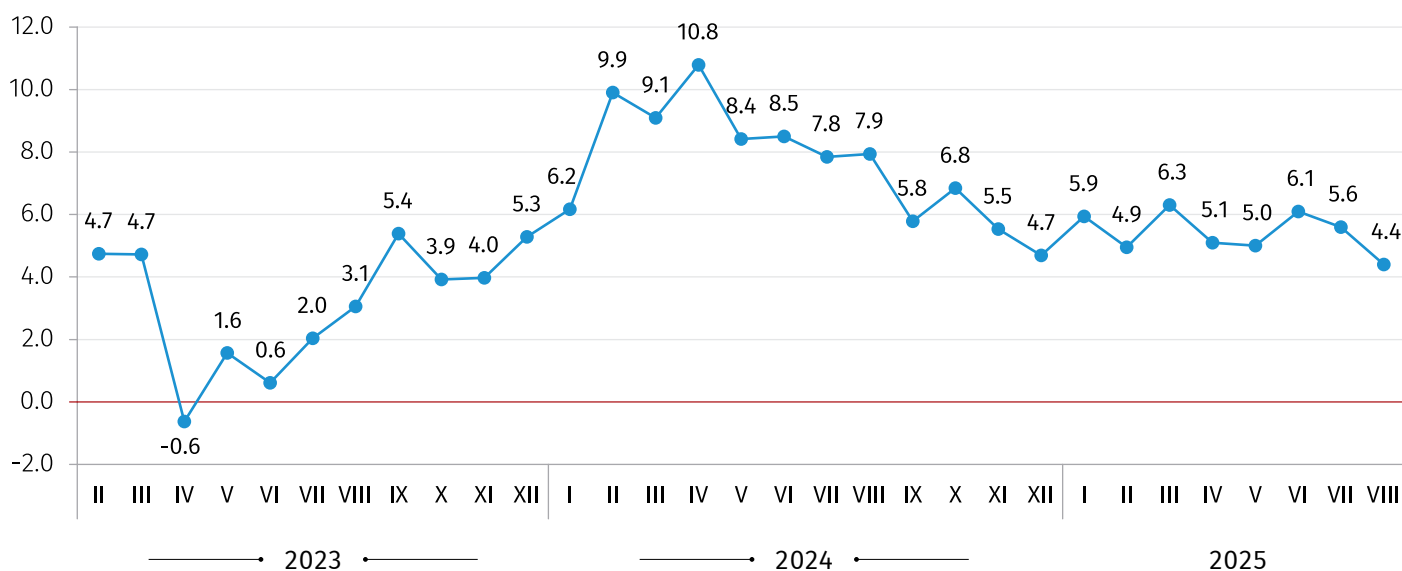
CONSTRUCTION COST INDEX CHANGE, % (COMPARED TO THE PREVIOUS MONTH)



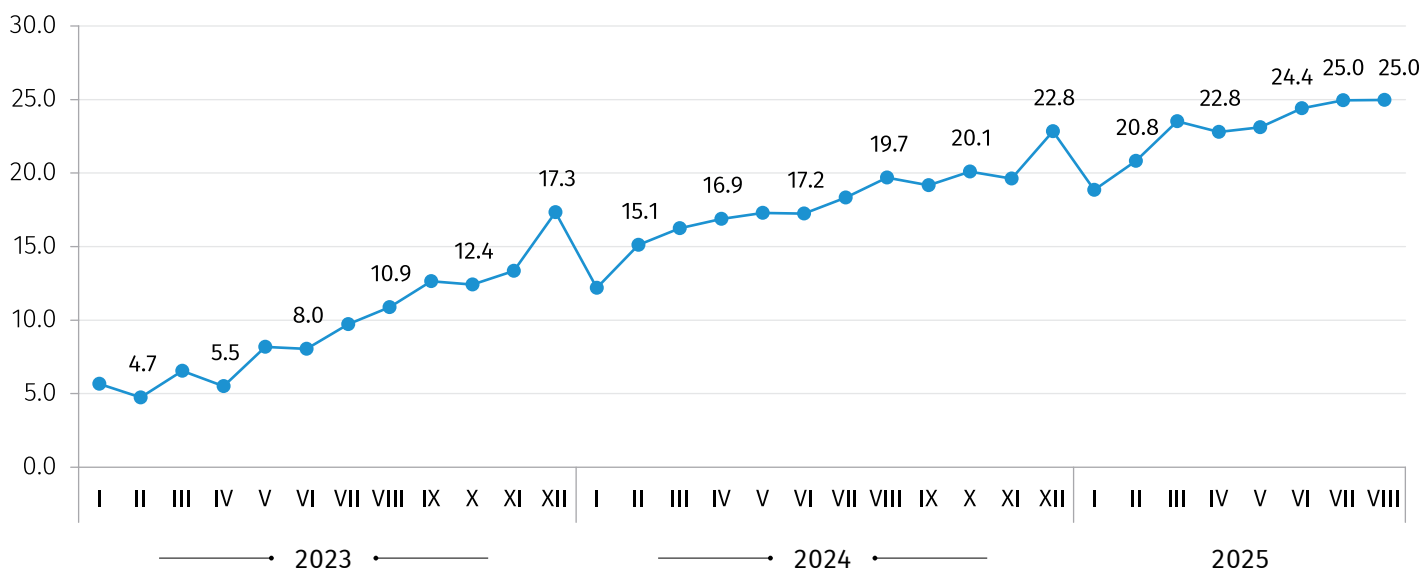
