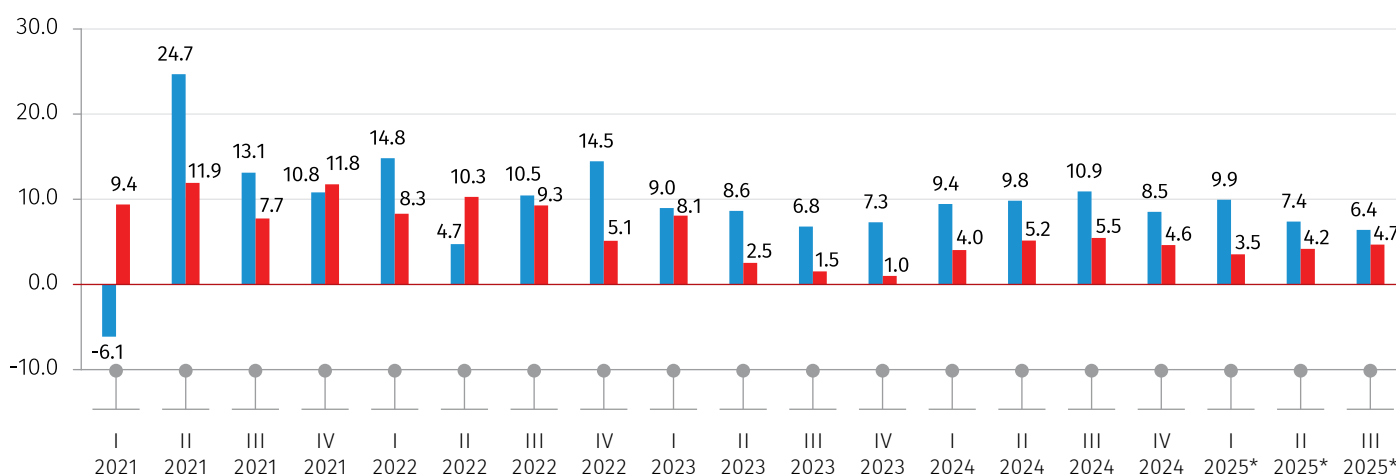
In Q3 2025 the nominal Gross Domestic Product (GDP) amounted to GEL 27 980.9 million. The real GDP increased by 6.4 percent YoY, while the GDP deflator percentage change equaled to 4.7 percent.

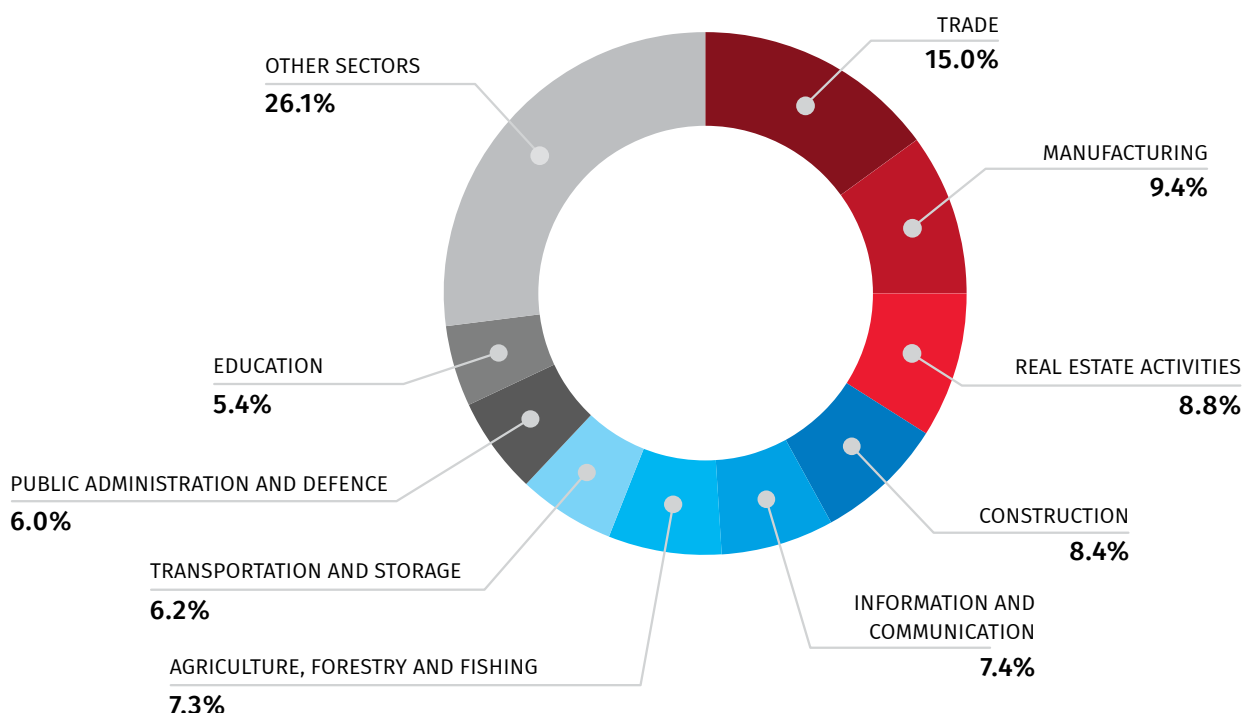

Significant contributions to the real GDP growth in Q3 2025 are related to increase of value-added of the following activities: Information and communication (21.1 percent), Education (20.7 percent), Financial and insurance activities (14.7 percent), Public administration and defence; compulsory social security (9.7 percent), Transportation and storage (8.1 percent), Arts, entertainment and recreation (13.0 percent), Wholesale and retail trade; repair of motor vehicles and motorcycles (3.0 percent).

A decrease in the real value-added occurred in Agriculture, forestry and fishing (-5.4 percent), Electricity, gas, steam and air conditioning supply (-3.3 percent), Mining and quarrying (-8.7 percent).

The largest share in GDP by activity is held by Trade (15.0 percent) and Manufacturing (9.4 percent), followed by Real estate activities (8.8 percent), Construction (8.4 percent), Information and communication (7.4 percent), Agriculture, forestry and fishing (7.3 percent), Public administration (6.0 percent), Education (5.4 percent).

INFORMATION NOTE

Calculation of the quarterly Gross Domestic Product is based on a monthly and quarterly data. The data of annual surveys usually differ from the quarterly data. Therefore, arises necessity of adjusting the quarterly GDP taking into account annual survey results.

After receiving the annual survey results for the previous year, four quarters of the previous year are adjusted along with the first and the second quarters of the current year. Final revision of 2025 quarters data will be conducted in November 2026, after receiving the data of annual surveys for 2025 year.
