

PRODUCER PRICE INDICES FOR SERVICES IN GEORGIA DECEMBER 2025

KEY POINTS:

- **Producer Price Index for Transportation and Storage Services** increased by 1.6 percent compared to the previous month and decreased by 1.1 percent compared to December 2024;
- **Producer Price Index for Telecommunication Services** decreased by 0.01 percent compared to the previous month, while the overall annual index went down by 0.2 percent;
- **Producer Price Index for Accommodation and Food Services** remained unchanged compared to the previous month, while the overall annual index went up by 6.1 percent.

PRODUCER PRICE INDEX FOR TRANSPORTATION AND STORAGE SERVICES

Producer Price Index for Transportation and Storage Services increased by 1.6 percent **compared to the previous month**. In the mentioned period the prices increased by 11.6 percent for air transport services and by 1.8 percent for water transport services. Along with this, the prices increased for land transport services and transport services via pipelines by 0.02 percent, while the prices for warehousing and support services for transportation decreased by 2.4 percent.

Compared to December 2024 the overall index decreased by 1.1 percent. In the period mentioned, the prices for warehousing and support services for transportation decreased by 10.6 percent, while for air transport services went down by 2.0 percent. At the same time, the prices decreased for land transport services and transport services via pipelines by 0.5 percent and increased by 11.9 percent for water transport services.

The following table presents the Producer Price Index for Transportation and Storage Services in December 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.

PRODUCER PRICE INDEX FOR TELECOMMUNICATION SERVICES

The total Producer Price Index for Telecommunication Services decreased by 0.01 percent **compared to the previous month**. In the mentioned period the prices decreased for other telecommunications services by 0.1 percent. while the prices for wired and wireless telecommunications services remained unchanged.

The overall index went down by 0.2 percent **compared to the same month of the previous year**. In the mentioned period the prices for other telecommunications services decreased by 9.1 percent. Along with this, the prices increased for wireless telecommunications services by 0.2 percent and by 2.2 percent for wired telecommunications services.

The following table presents the Producer Price Index for Telecommunication Services in December 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.

PRODUCER PRICE INDEX FOR ACCOMMODATION AND FOOD SERVICES

Producer Price Index for Accommodation and Food Services remained unchanged **compared to the previous month**. The prices decreased for accommodation services by 0.2 percent, while the prices for food and beverage serving services increased by 0.2 percent.

The overall index posted a 6.1 percent increase **compared to December 2024**. In the mentioned period the prices increased by 6.9 percent for food and beverage serving services, while the prices for accommodation services increased by 5.0 percent.

The following table presents the Producer Price Index for Accommodation and Food Services in December 2025 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.
