
PRODUCER PRICE INDICES FOR SERVICES IN GEORGIA

JANUARY 2026

KEY POINTS:

- **Producer Price Index for Transportation and Storage Services** decreased by 2.2 percent compared to the previous month and by 2.0 percent compared to January 2025;
- **Producer Price Index for Telecommunication Services** increased by 0.1 percent compared to the previous month, while the overall annual index went down by 0.2 percent;
- **Producer Price Index for Accommodation and Food Services** increased by 0.8 percent compared to the previous month, while the overall annual index went up by 8.5 percent.

**PRODUCER PRICE INDEX  
FOR TRANSPORTATION AND STORAGE SERVICES**

Producer Price Index for Transportation and Storage Services decreased by 2.2 percent **compared to the previous month**. In the mentioned period the prices decreased by 9.4 percent for air transport services and by 0.1 percent for warehousing and support services for transportation. Along with this, the prices increased for land transport services and transport services via pipelines by 0.4 percent, while the prices for water transport services increased by 1.1 percent.

**Compared to January 2025** the overall index decreased by 2.0 percent. In the period mentioned, the prices decreased by 7.1 percent for warehousing and support services for transportation and by 3.1 percent for air transport services. At the same time, the prices decreased for land transport services and transport services via pipelines by 0.2 percent and increased by 10.8 percent for water transport services.

### PRODUCER PRICE INDEX FOR TELECOMMUNICATION SERVICES

The total Producer Price Index for Telecommunication Services increased by 0.1 percent **compared to the previous month**. In the mentioned period the prices for other telecommunications services increased by 0.9 percent, while prices for wired and wireless telecommunications services remained unchanged.

The overall index went down by 0.2 percent **compared to the same month of the previous year**. In the mentioned period the prices for other telecommunications services decreased by 9.2 percent. Along with this, the prices increased for wireless telecommunications services by 0.2 percent and by 2.2 percent for wired telecommunications services.

The following table presents the Producer Price Index for Telecommunication Services in January 2026 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.

### PRODUCER PRICE INDEX FOR ACCOMMODATION AND FOOD SERVICES

Producer Price Index for Accommodation and Food Services went up by 0.8 percent **compared to the previous month**. The prices increased for accommodation services by 0.9 percent, while the prices for food and beverage serving services increased by 0.8 percent.

The overall index posted an 8.5 percent increase **compared to January 2025**. In the mentioned period the prices increased by 10.2 percent for accommodation services and by 7.3 percent for food and beverage serving services.

The following table presents the Producer Price Index for Accommodation and Food Services in January 2026 compared to the same month of the previous year and the relevant contributions of the main subgroups to the change in the overall index.
